## POLITICS and RELIGION TWO TOPICS YOU MUST TALK ABOUT

Henry Ford, a Freemason, said it first. "History is bunk". History is the systemic telling of false stories, about a series of apparently unrelated events that occurred in the past, in order to create an erroneous public opinion about who, what, where, when, why and how certain events took place.

## Premier of Ontario Kangaroos

To whom it concerns and to those who don't give a damn:

My name is Glen Kealey. I am Chairman and President of the Canadian Institute for Political Integrity. One might say that at CIPI we do work for the Creator. We take names — HE will kick ass later. We are inspired in this work by the related activities of the ancient Troglodyte "Grand Architect of the Universe". We break the fall of "stones the builders rejected".

On Monday, April 6, 1998, acting as an agent, I attended

with Mr. D. J. at an electronic hearing of the criminal compensation board (it was a telephone conference) held in two separate offices of the Attorney General of Ontario.

Today, I comprehend why the Commissioner refused to give us permission to tape record his "Hearing", although doing so is expressly permitted under Section 136.— (2) (b) of the Canadian Courts of Justice Act. The first three letters of Commissioner Lieber's name (lie) were to be but the first of many clues suggesting that although we were located in Ontario, Canada, (ie; not in Australia), we were to be

witnesses at a well renowned "Kangaroo Court".

The Commish, an obviously totally unqualified political appointment, showed so little regard for even a semblance of fairness during the entire hearing that one wonders if the man could even be trusted with the simplest task of raising money for his political sponsor's election needs. As he sucked up to the claimant and her "brother lawyer" one was, in fact, embarrassed for the dim *Brotherhood* that had accepted such a flawed character as one of theirs.

Also, his statement that he was

"not interested in reading, or even looking at the accused's court transcripts *holas-bolas*", claimant's perjury as she had testified under oath at previous court hearings, *blas*. He accepted "at face value", false words of the Durham police and prosecutors who just last week were accused by another Ontario Government inquiry, of having fabricated false evidence in the case of Guy Paul Morin.

The claimant's police statement in this case would have led to her being arrested for

driving while impaired, had it not been that the Durham police and prosecutors were out to fabricate evidence against the accused with regards to another unrelated case.

The accused has since been cleared in this other civil case, following a ten day trial which I also attended. He also has been compensated financially by his insurance company accusers, following a judge's order to that effect. These same Durham and RCMP police officers were totally discredited at trial and a

## CIPI — Who are we?



We are the Canadian Institute for Political Integrity (CIPI), a non-profit corporation dedicated to bringing about a truly democratic and independent Canada. While investigating, Kealey found evidence of a massive bribe and kickback scheme operated and controlled right out of the Prime Minister's Office, and a close collaboration among Cabinet Ministers, the national media and RCMP Commissioners. Glen Kealey, through a Section 507 Hearing, succeeded in convincing a Justice of the Peace, with 34 years experience, to lay charges against 16 senior politicians and government officials, including Norman Inkster, Commissioner of the RCMP, Henry Jensen, Deputy Commissioner and J. Michael Shoemaker, Assistant Deputy Commissioner, with having conspired together in a criminal conspiracy intended to cease and limit police investigations.

Clark is the civil servant, with 30 years experience, who worked for the Canada-U.S. Free Trade Negotiations Office in Ottawa and exposed an act of high treason committed by former Prime Minister Mulroney. She was ordered by the third highest ranking negotiator on Mulroney's team to come into the office between midnight and 4 a.m. in order to falsify and eventually shred briefing papers designed to mislead provincial premiers as to what was really being given away in the FTA (Free Trade Agreement). In March 1988, she was ordered by her boss to secretly remove key documents from the Free Trade Office and bring them to the trunk of his car. This order was given after he received an internal memorandum that ordered all negotiators to turn over to the National Archives all documents used in the negotiations. While screening the material to be removed, Shelley Ann Clark came across an implementation scheme that clearly laid out a step-by-step plan that would eventually lead to the merger of Canada and the U.S.A. by the year 2005. Clark stated that the scheme also contains plans for Quebec's separation, and the construction of a GRAND canal for massive water diversion. After being abandoned by PSAC, her union, and threatened by secret service, Clark went public with her story in May 1993, with the assistance of a lawyer. ## Mitch Bronfman's TAXSAVE scheme

# Revenue Canada tax collectors help steal \$ 4 billion - from you

To many people it would seem a career in government, and in particular, Revenue Canada, would be an excellent position. Guess Again! While the best sellers "Above the Law" and "On the Take" document widespread corruption in the Mulroney government, the following is a documented case of corruption in Revenue Canada.

The corruption, originally, was in the form of "Special Treatment" given to "friends" by managers in the department and because of "Special Rulings."

The major example of "Special Rulings" came in 1986 from Mr. R.F. Fulford, Assistant Deputy Minister, who, in a written directive unlawfully subverted the "Trust" section of the Excise Tax Act - Section 63 now Section 109, to the direct benefit of TaxSave Consultants Limited, a firm comprised mostly of former Revenue Canada executives and other colleagues of Mr. Fulford.

Section 63(109) of the "Sales Tax Statute" has been an integral part of this Statute for many years and states very clearly: Penalty for collecting excess sums—everyone liable under this Act to pay to Her Majesty any of the taxes hereby imposed, or to collect the same on her Majesty's behalf, who collects, under colour of this Act, any sum of money in excess of such sum as he is hereby required to pay to Her Majesty, shall pay to Her Majesty all moneys so collected, and shall, in addition, be liable to a penalty not exceeding five hundred dollars."

In 1985, the first year of Brian Mulroney's rule, a newly created company by the name of TaxSave Consultants produced a flashy marketing brochure describing their services. The TaxSave brochure boasts "Everybody's so Quiet About Us" — "TaxSave devised a strategy tailored to the situation, developed the issue, and pursued it. A few months later, Revenue Canada changed its policy and our

client was awarded a very substantial refund." The brochure also presents a client list consisting of approximately 800 companies across Canada.

What does the subversion of Section 63 mean? This Section is in the Sales Act to ensure businesses do not benefit from collecting too much tax or collecting tax on tax, i.e. on exempt items. The administration of Section 63 provided for over-charges to be refunded to the customer or sent to Revenue Canada, for return to the customer. Fulford's new directive allowed these businesses to keep over-collected tax money without refunding it to the customers who had been overcharged. The secret directive was not published through normal channels, so the general population of businesses were not even aware of it. TaxSave Consultants employees though were certainly aware of it—at least one full year before the directive from DM Fulford was issued, they were already endeavouring to exploit it. The pool of taxpayers' money they

prepared to tap into is estimated to be in the area of THREE OR FOUR BILLION DOLLARS!

In 1985, Jim Weiten, a senior Revenue Canada tax auditor researched this matter as soon as he first encountered the illegal activities of TaxSave Consultants Ltd.

At Weiten's request, a written directive was received from Ottawa (from the Senior Legal Counsel for Revenue Canada) and confirmed by the Department of Justice. It stated that Section 63 was in effect and was to be enforced as written.

After receiving this confirmation from Ottawa, Jim Weiten ensured that over-collected amounts were returned to the rightful owners — the customers who had been overcharged the tax. One of the activities TaxSave Consultants were involved with was advising a large furniture manufacturing firm in Winnipeg. They advised that they didn't have to return to their customers, the \$75,000 which they had over-collected,

because Section 63 of the Excise Act had been "changed". When Jim Weiten advised the manufacturer to the contrary that, in fact, Section 63(109) had not changed and was still law, they readily agreed with him that it didn't seem right to retain the money they had over-charged their customers. Of course, this meant that TaxSave Consultants Ltd. did not get its 50% commission for retrieving the over-collected amount from Revenue Canada

This development did not sit well with Jim Weiten's bosses at Revenue Canada. By sticking to the rules as stated in the Statute, TaxSave Consultants Limited would not be able to retrieve these illegal profits.

Weiten's managers at Revenue Canada were for the most part always ready to accommodate, by giving preferential treatment to former colleagues, including to a certain Mr. Harold Carley of TaxSave Consultants Ltd., a consulting firm reportedly under the control of Mitch Bronfman.

It is very significant that Mitch Bronfman first came to the public's attention when he was "named", during the 1970's, by the Quebec based "Commission into Organized Crime".

Mitch, who also owned a private exclusive airline for executives was accused of dealing with Willie Obront of the Zaputo Cheese Factory who was well known to authorities for his role in money laundering. Furthermore, avid KP readers should remember that before coming under organized crime investigators scrutiny, Mitch, who always demonstrated an unusual eye for bargains, had purchased land at Georgian Bay, on Lake Huron, in 1966, for much more than its estimated value (coincidentally this is the area where the proposed \$196 billion Grand Canal project is expected to unload its valuable cargo of fresh water — once it is diverted from a newly desalinated James Bay).

The Bronfmans, of course,

also control the huge Seagram empire which was built on the import-export of whiskey to elements of organized crime in the U.S.A., during "prohibition". They are also the same people who convinced Kim Campbell, in 1993, to privatize the Toronto airport, during the federal election campaign. In any event, mostly because of Prime Minister Chretien's "sweetheart settlement" the Bronfmans still made their multi-million dollar profit, when the questionable airport sale was cancelled due to public pressure.

A harassment campaign, orchestrated by Weiten's four managers, was launched against him.

According to Weiten, the managers involved in this were: Barry Lloyd, Audit Unit Manager, Merv Sitka, Audit Unit Manager, George Stratton (brother of Senator Terrance R. Stratton), Audit Unit Manager and Augie Haugen, the Regional Chief of Audit.

It is significant before proceeding further, for the reader to fully comprehend how the *Government's Personnel Management Manual* defines the term "harassment".

The Canadian Government's *Personnel Management Manual* clearly states:— "Harassment also includes abuse of authority, which means — an individual's improper use of power and authority inherent to the position held, or, to endanger an employee's job, threaten the economic livelihood of the employee, or, in any way interfere with or influence the career of such an employee. It includes such Acts or misuses of power as intimidation, threats, blackmail or coercion."

In 1986 Deputy Minister Fulford issued his new directive, illegally subverting Section 63, despite legal advice received from a senior Counsel and the Federal Department of Justice as outlined above.

To explain further, for example, when a supermarket

or other business collects sales tax on items which are exempt such as meat, milk, bread and other food items, this would be a violation of Section 63(109) of the *Excise Tax Act*. When Fulford issued his illegal directive not only did he know he was in violation of this *Act* but he also knew that it would be overlooked by his officials.

Normally, a business probably would not do this on their own, but if they were prompted by a firm such as TaxSave, it would be simple for them to program their computerized cash register to take these exempt items into the taxable field on their computer. Under Fulford's directive they could retain this tax illegally collected, and TaxSave, under its contract, would keep 50% as a commission for retrieving these illegal funds "legally" from Revenue Canada.

Ted Reid, a tax interpretations officer in Winnipeg, immediately wrote a letter to Ottawa questioning the motive and legality of the directive. The letter was written as a result of requests from the staff in Winnipeg who wished to receive a clarification, as the directive made no legal or practical sense.

Reid's letter clearly indicated that the directive made the Department "party to a fraud". Reid's questioning of the directive cost him his career. He was immediately subjected to harassment by his managers. The harassment included falsifying his work records by one of his manager's, Ed Luy. Mr. Luy removed all favourable comments from Ted's formal work record files.

The conduct of managers, Sitka and Luy was so biased, that an Adjudicator, in her 58 page report made comments such as ... "He" (Luy) "had also created an intolerable work environment for Mr. Reid". ... "Messrs Jordan, Sitka and Luy devised a game plan, obviously to get rid of Mr. Reid". ... "I do not believe Mr. Luy's statement". "I believe Mr. Reid over Mr. Luy's declaration". ... "The written evidence clearly and

 unambiguously contradict this (Sitka's) statement." ... "Mr. Jordan (Regional Director) testified that the urgency of the situation had required that he sign two blank copies of the disciplinary action reports. Such urgency is hard to explain".

Despite the managers being named by the adjudicator, for having obviously lied under oath, violating various employment statutes with misconduct, which could arguably be described as criminal — What has been their fate? You guessed it. They all received promotions, of course! At first, Ted Reid appeared to have finally won his reinstatement, with all of his back pay. Mr. Reid's superiors' testimony had not been credible, as shown in the foregoing examples. Still, the Department refused to pay Ted's legally won backpay. Instead, they fired him again — before he could physically get back into the Department. The Adjudicator had also added that "Mr. Reid had been a fully satisfactory employee with no disciplinary record".

Why do you suppose it was suddenly so important for Revenue Canada managers to get rid of Ted Reid, a fully satisfactory employee over a 10 year period.

In 1988, Finance Minister, Michael Wilson, in response to a letter from MP, Ronald Stewart, advised that over-collections had to be returned to the customer and not retained by the vendor. This is in keeping with the provisions of Section 63 of the *Excise Tax Act*. Even though this missive totally contradicts then Revenue DM Fulford's directive, Fulford's directive remains in effect. To this day, it still allows TaxSave Consultants to make millions of dollars for themselves by stealing from the taxpayers.

In fact, Otto Jelinek, Minister of National Revenue at the time, wrote a letter to M.P. Bill Blaikie and advised Section 63 was still in effect "in certain instances" moneys must be returned to the customers or to Revenue Canada.

In other words, if excess sums of taxes are collected from customers and a TaxSave Consultant is hired to represent the vendor, they can

keep the excess moneys which were collected illegally. In all other cases, the excess moneys must be returned to the customers or to Revenue Canada.

The "cone of silence" was placed over Revenue Canada. The order came right out of Brian Mulroney's Office right down to the regional level where those directly involved were desperately trying to keep the lid on this criminal activity and all other corruption activities.

Jim Weiten continued to uncover more and more corruption within Revenue Canada, including the forgery of his name on a document which illegally cancelled huge amounts of statutory penalty and interest owed by a large corporation.

Once again, Jim Weiten reported the illegal activity to the Winnipeg Regional Office. It was, of course promptly ignored. Weiten then brought it to the attention of his representative at the Public Service of Canada and later to the RCMP. You guessed it again! The end result was just the usual run-around and cover-up.

After this latest incident, the harassment of Jim Weiten intensified. He was obstructed from doing his job; he was ridiculed and slandered by the Revenue Canada managers. This horrific harassment was obviously not sufficient for his managers, because they then enlisted the assistance of someone they could easily manipulate, one Doug McLean. McLean's sole claim to fame was that he owned a .357 magnum and shot jackrabbits for practice.

While sitting in his office McLean's favourite pastime was to "fondle" the bullets he had in his desk drawer. His mission was obvious — get rid of Jim Weiten.

In the end, the severe harassment upon Jim Weiten took its toll. Jim encountered severe medical problems and had to take an extended leave.

Subsequently, the local RCMP "Commercial Crime Unit" were advised of the Section 63 tax fraud and the penalty and interest offences. Two RCMP officers were assigned to the case, but only one showed any

interest. Officer Jennings stated (once outside the building) that this case had the potential for a "heck of a case". However, Jennings also said "that Bill C-79 and a directive from the Commissioner — do not let us investigate government any longer." (In the Glen Kealey case RCMP Commissioner Norman Inkster and his two Deputies were charged with "ceasing and limiting police investigations". The charge was withdrawn as a result of Mulroney's political appointments to the Bench. Five corrupt prosecutors became judges.) Jennings also said that they once had 15 senators and politicians under investigation in Ottawa but Bill C-79 had suspended these investigations.

Despite the fact that the Section 63 SCAM was aired on CBC's national news program "The Journal" and that the CBC crew investigated and interviewed the principals of TaxSave Consultants officials in Toronto and Winnipeg and did a hidden camera interview with Harold Carley of TaxSave, catching him "red handed" — Revenue Canada officials in Ottawa would not comment — Once the Bronfman's participation in the scam was clearly understood by all in the media 'THE LID WAS ON'.

In July 1992, a billion dollar class action suit was filed in the Federal Court on behalf of purchasers who had been over-charged federal sales tax and defrauded of the money owed to them.

Suddenly, by coincidence, Mr. R.F. Fulford, Assistant Deputy Minister of Revenue Canada, retired even though a few months earlier he received the Outstanding Achievement award from Brian Mulroney and Governor General Ramon Hnatyshyn for his role in implementing the GST.

Fred Corbet, Deputy minister of Finance (architect of the GST) also "resigned" on short notice. As well, Ruth Hubbard, Deputy Minister of Revenue Canada was quietly transferred.

Enter Pierre Gravelle as the replacement Deputy Minister, Revenue Canada. This is the same person who, lately, has allowed the Bronfman family trust to remove \$2 billion,

parked tax-free, in the Bronfman "family trust" from Canada, without paying any taxes.

complaint of perjury was filed by our institute against a number of the officers involved.





NELSON — She says it's a threat to national security, and the truth has to get out.

So far, hundreds of dismayed people have turned out to hear civil servant Shelley Ann Clark claim the free-trade agreement is a fraud.

"I was the person who rigged the free-trade agreement," said Clark. "I doctored and shredded the briefing books given to the premiers."

"No one has the complete agreement because I took seven boxes of documents to (my boss's) car."

Clark says 200 to 500 pages are missing — and they will turn Canada into the 51st state by 2005.

Clark, 49, says she was executive secretary to a free-trade negotiator in 1986 and 1987. She says she was told several times a week in January 1987 to report for work between midnight and 4 a.m. to shred and alter documents.

"I knew the briefing books were being doctored. I demanded to be

removed six times, but my requests were denied."

She says one of the missing documents is an implementation scheme. It discusses the separation of Quebec in 1995 and completion of the Grand Canal in 2005. Both Canadians became Americans.

The Grand Canal is a \$100-billion project to divert water from James Bay to the Mississippi River.

Allegations of tampering with free-trade documents were investigated last summer by the RCMP.

"The investigation is finished and no accusations came out of it," said Rodney Moore of the external affairs department, Clark's employer.

More than 200 people turned out to hear Clark in Fruitvale, Nakusp, Nelson and Kaslo two weeks ago.

"I can't fathom anyone doing this without having some grounds," said Allison Bowles of Fruitvale.

Said Clark: "I used to be horrified of losing my job. It has taken me six years to say 'to hell with the job.' I want to get this message out."

I wish to advise you that it is



held civilly and criminally responsible for your actions; actions that are without doubt designed to aggravate my wife's deteriorating medical condition. Once your actions are fully understood by Canadians — how you joined in the pattern of attack on Ann's health which were begun by the military attache, Colonel Bill McGill, at Ambassador David Peel's residence in Vienna and continued through actions of Ambassador Gerald Shannon in Geneva — mark my words, they will react.

### To the people of Canada and the Media

Dear Editor,

At the end of Feb/98, the Canadian Press issued a statement from Gordon Luchia, a spokesman for Revenue Canada stating that, "Canadians have to pay income tax on their earnings to the federal government". Gordon Luchia lies to Canadians. Tell big lies and if you tell the same lies often enough, two things will happen: 1) some people will believe what you tell them, or 2) you will end up believing your own lies.

Revenue Canada has done a fantastic job of brainwashing Canadians into believing that federal income tax is legal. Nothing could be further from the truth. Here are a few facts that Revenue Canada and Gordon Luchia are deliberately hiding from the public.

FACT: No one has to pay income tax to the Federal Government. Federal income tax is illegal under sec. 92 par. 2 of the constitution which states "The provinces have exclusive right to all direct taxation; i.e. income tax and sales tax".

FACT: Section 92 was the first section to be written, all other sections revolve around it.

FACT: The Federal Government and Revenue Canada cannot take out of context any section of the Constitution; i.e. sec. 91 par. 3 "or make laws" — the income tax act and the excise act — to try to legitimize their criminal activities. Section 52 of the Constitution states; "the Constitution of Canada is the supreme law of Canada, any laws that politicians make that are not consistent with this Constitution are of no force or effect". To use the legal term, such laws are Ultra Virus in a court of law, they cannot do not exist.

FACT: On Oct. 3/1950 the Supreme Court of Canada, by a unanimous decision 7-0 (Lord Nelson hotel and AG Nova Scotia vs AG Canada) stated that federal income tax is illegal, and no one, including the people who work for Revenue Canada are allowed to live above the law. The government was ordered to run the nation according to the Constitution.

FACT: In Winnipeg, in 1959, the workers of Revenue Canada defied the Supreme Court of Canada and charged Mr. Gerry Hart with tax evasion. Mr. Hart stated that under the Constitution and with the Supreme Court's

ruling of Oct. 3, 1950 federal tax does not exist, therefore he could not be guilty of not paying it. The court agreed and they reminded the government with the following, "If you need money, then run this nation according to the Constitution". That decision was immediately appealed to a higher court. The higher court agreed with the lower court and once again the government was told "If you need money, then run this nation according to the Constitution".

FACT: According to the Constitution, under sec. 91 par. 14, the government has the exclusive right to create money. If the government obeyed the Constitution and made the money and charged 5% interest on the money they then loaned to banks, on \$3 trillion they would receive \$150 billion. Since it only costs \$100 billion a year to run this nation they would make a profit of \$50 billion to pass on to the provinces in transfer payments. This would help cover the cost of health, education and welfare, etc..

FACT: We are \$570 billion in debt, hospitals are closing, doctors and nurses are over-worked and Canadians are dying from lack of medical

FACT: In Toronto, in Feb. / 1995, workers from Revenue Canada once more showed their contempt for this nation's laws, by charging Mr. Joseph Axler with tax evasion. In court file #T-3025-95 it says Mr. Axler was found not guilty. The judge told Revenue Canada not to appeal his decision unless they can prove that federal tax is legal under the Constitution. As of Apr. / 98 Revenue Canada had not appealed. However, Mr. Axler

sued Revenue Canada for stealing his property in the '70s. Axler wanted the money from the sale of that property, plus interest, plus all his court costs over 20 years. Consider yourself to be on notice and act accordingly. Canadians will know what happens.


PS: Revenue Canada employees ignored our request and proceeded to seize a further 30% of Ann's disability allowance leaving her with only 49% of her former income.
