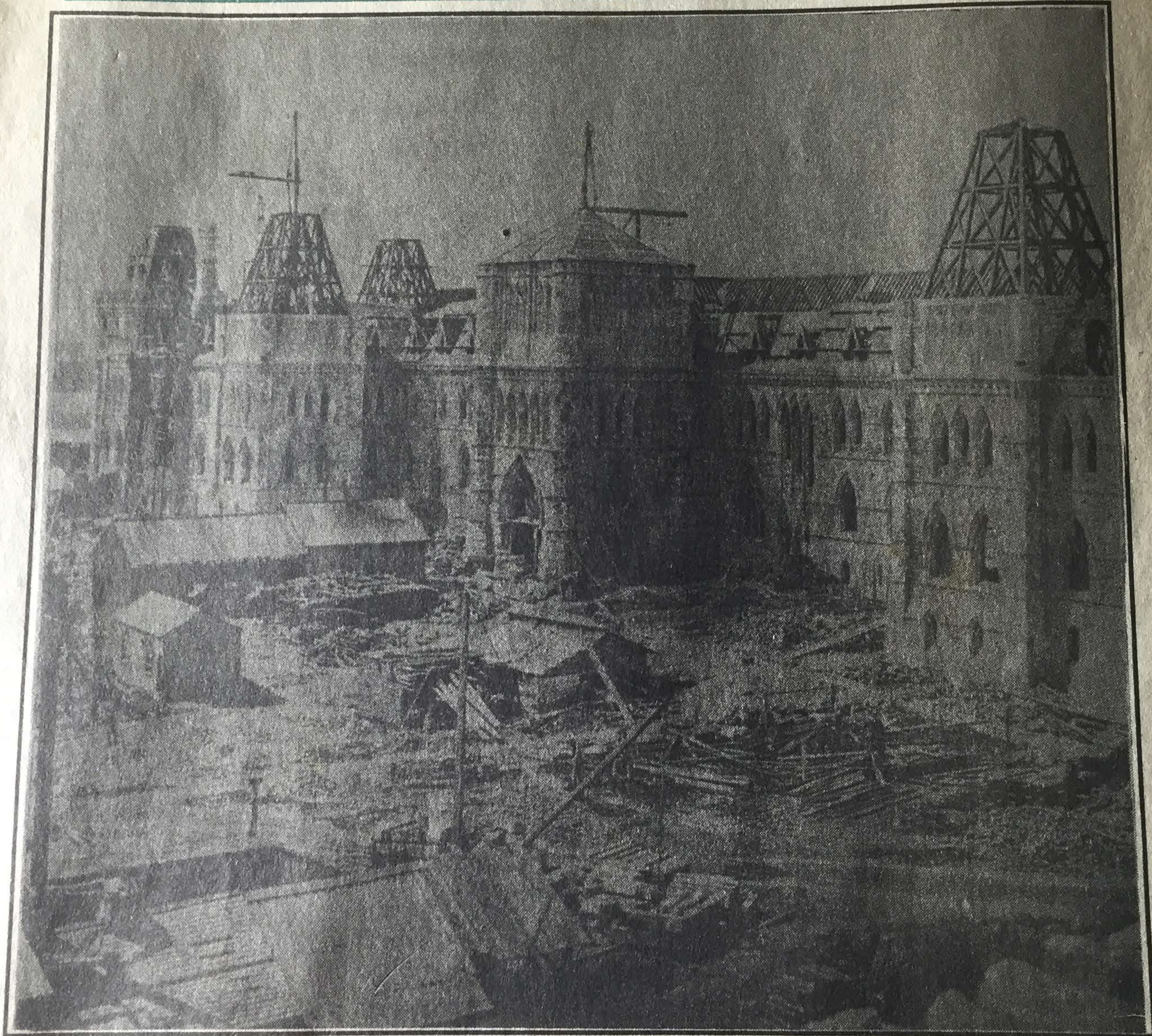

Andrew Hardy charged with "mischief & endangerment" to life.

What ever happened to "innocent until proven guilty?" An Ottawa area man, Andrew Hardy, found out the hard way that justice is just an illusion in this country and that the middle class and the poor must never have the audacity to complain to the Red Cross Society of Canada. Judge Krever can get away with it, but ordinary Canadians who complain could face a joint police force operation and land in jail.

On Friday evening, December 16, 1994, Hardy sat peacefully in the living room of his home. He had no idea his whole world was about to be turned upside down and that all he believed in during his entire life had been nothing more than

an illusion. Andrew Hardy found out the hard way that Canada's justice system is not on the side of ordinary middle-class Canadians. That is why the "system" has been dubbed "THE JUST US" system. It is a legal industry that cares only about \$.

Ordinary middle-class Canadians who complain to the Red Cross are increasingly likely to be arrested and land in jail.

On a fateful Friday evening in December 1994, Hardy's thoughts were interrupted by the ringing of the front door bell. Surprised at the unexpected visit, he

Back to the future Canadian style.

Did Brian Mulroney's Secret 5% "Kickback Tax" on Canadians Buy the CNR?

Unless the Assembly of Independent Canadians (AIC) finally succeeds in awakening Canadians, Canada, in the 21st century, will look very much like Britain did, in the 18th century. Our few remaining industries will be natural resource based. International bankers will have used each of their instruments of people control; central banking, cartels, taxation, inflation, usury, bribery, blackmail, war and free trade in order to perpetuate world poverty. We will all be poor.

Furthermore, Canadians will be oppressed in 300 newly defined neighbourhoods (elitist euphemism for 300 middle-class reserves), by political crime bosses (read Rothschild's latest book "Our Global Neighbourhood") supported locally

by a police state apparatus destined to enforce a system of kickbacks collected from extortion charged on all private and public barter or sale of goods and/or services. Significantly, two Canadian models for the new job of criminal political crime boss are our former PM Brian Mulroney or Marcel Beaudry, the current chairman of the NCC (the National Capital Commission).

The GRAND CANAL (Great River and Northern Development) project, planned since at least 1966, will have been completed. Fresh water will be diverted from James Bay in the east and the Fraser river in the West, merging in southern Saskatchewan. The water will be used to irrigate vast corporate owned farms in the central

and southern United States. This guaranteed source of fresh water will allow the international bankers who currently control the United States' administration to create their most important world cartel to date. The

New World Order food cartel's physical security will be guaranteed by an American based but

European (NATO - Rothschild) owned, managed and controlled military force. Yes, my friends, they are coming to a grocery store near you: Watch for them; "ADM - supermarket to the world."

Apart from the fresh water itself, barges, floating on the GRAND CANAL, will criss-cross each other on their respective journeys, as they move Canadian natural and farm

resources such as oil, beef, lumber and minerals south of the border around the clock. On their return trip these barges will bring back American and Mexican lethal garbage, for permanent disposal at the Meadow Lake Band Reserve in Saskatchewan and down abandoned mine shafts in B.C. and elsewhere across the country.

Canadian railways will be dismantled, their original right-of-way having been sold to the "private sector" (to international bankers), by Mulroney's former Clerk of the Privy Council, Paul Tellier, for the ridiculous low price of 34 Airbus planes. Will the CNR land eventually be used as a road bed for the GRAND WATER AND BARGE CANAL? Is this not the project that

quickly moved to open the door. Imagine his shock when he came face to face with three police officers pushing on the door as they entered with a search warrant thrust in his face. They demanded to know where he kept his tape recorder and audio tapes. When Hardy said he didn't own one they respectfully took his word for it while completing a cursory check of the house.

Two of the attending officers were from the Ottawa Police, Sergeant Ron Picard and Detective Paul Quesnel. They were accompanied by a third officer from the OPP, Poncho Jacot. The arresting officers took Hardy from his home, frisked him outside and told him he could have been both shackled and hand-cuffed before driving him to jail on Elgin Street. The whole process was incredibly intimidating.

The charge was one of Mischief Endangering Life. The complaint

laid following receipt of a faxed letter to the police, from Nadia Senyk, Legal Counsel for the Red Cross Society of Canada's national office headquarters at 1800 Alta Vista Drive, Ottawa.

The story began a week or so earlier when Hardy watched a televised statement made by the Secretary General of the Red Cross of Canada, Doug Lindores, relating to the Commission's Hearing on Blood Safety (Toronto, December 6-9, 1994). Mr. Lindores, on national television stated, "in my opinion, Canada's Blood Supply is safe, and in particular, as safe as any in the world today". Because Hardy has a very different opinion in this regard he called Lindores, out of concern for his community. As the Secretary

than perfect and as such, could easily be compromised. At this point the doctor asked Hardy what he meant by this. Hardy suggested that actors could be sent to the 85 Plymouth Street clinic (with fake ID) who could then lie to the staff while completing the donor interviews. Hardy believed these people (the actors) could tell their story about how easy it had been for them to compromise the Red Cross blood screening process - in order for them to inform the public - within an investigative news report format, such as is used by W5 or The Fifth Estate. former Tory/Mulroney Environment Minister, Tory Suzanne Blais-Grenier testified about in an Ottawa court of law, in 1991 (at the Kealey/Coulter Hearing)? She swore she was told the project would only be put in place following Mulroney's retirement.

Politicians, Police Chiefs and National Media "Conspire to destroy Canada"

The links are becoming too obvious for Canadians to ignore. Is the Justice Department and the Royal Canadian Mounted Police involved in a conspiracy, with former and current federal politicians and the national media, to defraud ordinary Canadians of their birthright?

Let's look at the preponderance of circumstantial evidence available so far.

Suzanne Blais-Grenier testified, in 1991, that former Prime Minister Brian Mulroney had collected a secret 5% kickback tax on all major contracts granted by his Tory government, during her tenure as Environment Minister. No evidence has come to light since to suggest that these kickbacks ended with her departure from politics. She also testified that the money (apparently billions of dollars)

would be used, by Mulroney, following his retirement.

During his time in office, Mulroney along with his Clerk of the Privy Council, through Air Canada, purchased 34 Airbus planes from a French-German-British consortium controlled by New World Order bankers (Rothschild), for the sum of \$2 billion.

During his final days in office, Mulroney appointed Paul Tellier to the post of President of Canadian National Railways (CNR). Tellier announced he would "privatize" CNR which, in political language, means to sell it to their friends for less than fair market value.

Upon retirement Mulroney was hired by the bankers' gold cartel

(Barrick Resources) and also by their food cartel (ADM - Supermarket to the World). Then he was hired by Ogilvy-Renault, the oldest law firm in Canada. Angus Ogilvy is the legal counsel to Queen Elizabeth II. He decides, she signs. Ogilvy is the Queen's and the British oligarchy's link to bankers (Rothschild). Brian Mulroney's 1995 income was close to \$1 million, equal to his total nine years in public office. In 1993, he bought a mansion, in Westmount, (an elitist suburb of Montreal) for \$1.7 million. This huge house was first listed at \$3.3 million only weeks before.

Bankers own Gold, Diamond, Banking, Pharmaceutical and Illicit Drug Cartels

It is suspected that Mulroney's secret fund is being used to finance the coming GRAND Canal water diversion project.

The canal will divert Canadian water and float barges loaded with natural resources, like a moving sidewalk rolling across Western Canada, bobbing goods south to the USA and Mexico. Maurice Strong is expected to participate in this water scheme from the comfort of his ranch located in Colorado. (Read *Cloak of Green* by Elaine Dewar).

Recently, Chretien's Liberal government (that is being secretly managed by Mitchell Sharp for the international bankers), approved the sale of CNR for the ridiculous low price of \$2 billion. By coincidence, Air Canada had paid the same price for 34 Airbus planes. These new planes were built in Bavaria by a company managed and controlled by the now

deceased Chancellor of Bavaria, Franz Joseph Strauss. Strauss' son Max is in business in Alberta with a certain Karlheinz Schreiber, who has been linked recently to Frank Moores, Mulroney's former friend and "personal lobbyist".

Can it be that the CNR roadbed, in Western Canada, will serve as a right-of-way for Brian Mulroney's GRAND canal project? Is it not also possible, that the millions of tax dollars spent by the RCMP to remove 18 "Defenders of the Shuswap Nation" from a small piece of land, ("parked" at Gustafsen

Lake, B.C., with an American rancher, under fee-simple title), was only realized in order to clear this strategically placed piece of land prior to the construction of the GRAND canal's western terminal, in northern B.C.? Are the Lubicon Cree of northern Alberta not also horrified at the thought of 11,000 trees being harvested from their traditional land daily and then floated on barges to Saskatchewan, before proceeding south to the USA? Will Lubicon leaders, like their Meadow Lake brothers and sisters, also be paid in cash to accept and store dangerous nuclear waste or, will it be other, "regular" garbage that will be brought back to their reserve by the canal barges, on the return voyage?

"Billions" for the Bankers "Poverty" for the People

What if Canadians discover "THE PLOT TO END ALL PLOTS"

Therefore, would it not be appropriate, as a precautionary measure, for the political conspirators to grasp the upper hand before their weakest link, Brian Mulroney, is dragged into court kicking and screaming, ready to blow the whistle on the entire cabal? Would it not make some sense that they would want to hurriedly orchestrate a totally "impenetrable legal protection from prosecution" for our former Prime Minister?

Dear Eva,

If I may offer a couple of unsolicited comments (please take them as from a friend), I would urge caution in the tone, that is the subject matter is already explosive enough, you might be accused - probably will be anyway - of a variety of "isms". Thank you for your encouraging words about the first Kealey Paper.

Thank you also for your warning about the possibility of being accused of "isms", or for appearing to protect individuals who would steal private land. If this were true, I can assure you that I would have nothing to do with either situation. However, let me deal with each of these issues separately.

When it comes to "isms", my conclusion, following many years of observation, research and analysis, is that each of these "isms" is being centrally managed from a country newly created for just that purpose. It is a place called Switzerland. This country, Switzerland, was incorporated in 1848, following a decision made by rich bankers in 1815, at the Conference in Vienna. The urgent meeting of European political and financial leaders was called by the Rothschild family, following the defeat of France by Wellington at Waterloo, to set up a state from which a "League of Nations" would eventually own and manage a New World Order.

World Communism was born there in Switzerland (with Engels and Marx). So was world Capitalism, including world banking, world trade and world poverty. They are all being managed from there. World Fascism is also headquartered in Lausanne, Switzerland. The "competing" political systems are, in fact, one and the same. They are centrally managed ruses designed to mislead the 87% of the people of the world who can be fooled by the banker controlled "national" media, the so-called "free press". They always divide to conquer.

Together they create national debt by promoting wars and the fear of wars. The resulting "debt" invariably leads nations into more debt, and eventually, into bankruptcy. In this manner international bankers get to "repossess" all of the natural resources of the world "legally", one country at a time.

I am not at all surprised, but rather, I am flattered, that I am being singled out by the Rothschild ADL defamation league with the resulting "special attention". This confirms that I have accurately identified our nation's cancer. As you know, Eva, cancer cannot be ignored. Neither can it ever be cured by placing a band-aid on it's visible surface sores, in lieu of aggressively dealing with the cause of these sores.

Eva, if I am to be personally attacked just because I point out the world connections that most people are, to date, unable to identify for themselves due to our controlled media, then so be it. I believe this to be my assigned task, at least in this current life.

And now Eva, with regards to the issue of Gustafsen Lake. You asked of my experience with Wolverine and the implications that would result "if Native groups claim land held in private hands by persons who purchased this land in good faith".

Let me begin by stating that neither I, nor as far as I know Wolverine, believe that land held in private hands, of less than 1,000 acres and owned for the purpose of creating a homestead or a business, that was purchased in good faith is today at risk of being claimed by Native land claims supported by

"traditional" aboriginals. Native born politicians, the native "elected" tribal councils, who sold out their native birthright and are in league with our own corrupt Canadian politicians, are the only ones making these ridiculous land claims (115% of B.C.).

First Eva, as you, yourself, would surely refuse to accept any blame for the vile actions of our corrupt Canadian politicians, so then does Wolverine, along with other traditional natives he knows, reject the totally ludicrous claims made by servile tribal councils.

Second, you would surely agree with me Eva, that Wolverine is innocent, until he is found guilty by a jury of his peers. This also raises the additional side issue of how will we ever assemble, under the existing judicial system presently managed by the legal industry, "a truly unbiased jury of Wolverine's peers"; the people who do not accept that there has ever existed a statute of limitations on land theft (his peers would belong to same traditional native and Canadian groups who believe that we should create some form of parallel government with the original peoples of Canada - i.e. the AIC).

Third, for the courts to find a person guilty of any crime, they must first establish, "beyond any reasonable doubt", that: a) the person accused committed the crime; and b) he knew, or should have known, his actions to be criminal - i.e. he committed the crime with "a guilty mind". In the case of Wolverine, (this is where I have an advantage over those who only get their news from the "controlled"

national media), I know that in July, he personally had witnessed a police researcher, a member of "our" Royal Canadian Mounted Police, confirm that the land in question at Gustafsen Lake had in fact been stolen from the Shuswap people by the government of B.C. The evidence is part of a video that was made inside the camp by a Vancouver based freelance photo-grapher (the video is available from us at CIPI upon request).

According to existing legal documents, the land was "parked" with an American rancher (for future exploitation), by means of a "fee simple title". Legal ownership over the land by the Shuswap people was also confirmed by means of Wolverine's sole legal counsel at the time, Mr. Bruce Clark. When one has considered all of these facts, it then becomes evident that Wolverine could never have committed any of the crimes that he is being charged with, he was simply acting in self-defence.

Canadians must accept that traditional natives need a land base. Of course, this would not necessitate the transfer of any existing private property nor would this require payment for the land from the pockets of middle-class taxpayers - in the form of a larger national debt. It would simply mean the transfer, by the governments, of land they originally stole from natives - i.e.:

- Legal title to land of existing native reserves.
- Legal title to all "Crown" land.
- Legal title to "fee simple" titled properties in excess of 1,000 acres.

World rulers employ Canadian politicians in water diversion plan

A good portion of the new world order's reprogramming of Canadian political leaders has been in service of the massive GRAND Canal water diversion project, planned for Canada in the near future.

The GRAND (Great Recycling and Northern Development) Canal means fresh water, diverted by new canals (from James Bay, Ungava in the east and from the Fraser River, British Columbia, in the west), is to converge at Lake Diefenbaker in Saskatchewan, and then flow south to guarantee the new world order (NWO)'s North American food cartel gets a year-round food supply.

The fact that water will be diverted from the Fraser River, near Williams and Gustafsen Lakes, across land held by American ranchers who hold the land on "free samples" titles might explain why so much fire-power was brought into the standoff between traditional Natives and the military and RCMP last summer.

British Columbian fresh water will be diverted out of the mountains before it becomes polluted with deadly cyanide (a byproduct of the mining industry) which is now found in underground water in the southern half of B.C. New canals redirecting the river towards Alberta will provide water to the northern cattle who graze on these 500,000-acre ranches before water converges with the eastern canal at the Lake Diefenbaker reservoir.

GRAND Canal will float barges

This plan finally explains the hidden agenda that necessitated the construction of numerous new dams in Alberta and Saskatchewan, in areas without enough water to dam.

From Saskatchewan, the water will provide irrigation to the northern grain-growing states, then move south to the ranch of high-profile Canadian industrialist Maurice Strong, replenishing his underground

aquifer. Strong, known for master-minding environmental summits, will now be able to set the price of the water he directs south and southwest to fruit and vegetable growers of the southern states and Mexico.

Nevada, New Mexico, and Arizona will also benefit greatly as the cheap desert land (controlled by mobsters) will become expensive private development property with relatively cheap outdoor climate control.

The vast region will be defended by a police-state bureaucracy whose well-armed police will be backed by the military. Citizens will see their guns confiscated. The new world order food cartel will be in place.

Who runs this food cartel and how did these people get there?

Brian Mulroney spent his life being trained (programmed) by the new world order (Hanna Mining, RJR Nabisco and Kuhn Loeb/American Express) and eventually was raised to the lofty position of prime minister of Canada. Beginning in 1985, for nine years, Mulroney imposed a secret five per cent "surtax" on all Canadians - a five percent kick back scheme on all major government contracts (as was testified to under oath by former environment minister Suzanne Blais-Grenier, in 1991, during the Coulter/Kealey Hearing). Mulroney now intends to use this money (maybe as much as \$100 billion) to rescue the construction of, and later control, the GRAND Canal project. After carrying out the new world order's plans during his time as prime minister, he was made a director of the trans-national food company Archer-Daniels-Midland.

Lucien Bouchard was programmed when Brian Mulroney appointed him Canada's ambassador to France in 1985. Reportedly, he attended the meeting held at Airbus with Frank Moores and Mulroney. It is quite conceivable the secret Swiss bank accounts set up for the purpose of receiving the Airbus bribes were opened on behalf of all three ("Frank Moores & BM" could have meant Moores, Bouchard and Mulroney). The illicit Airbus bribe money could explain how the Bloc Quebecois was funded. Bouchard's importance to

the new world order is in his role of arranging Quebec's separation. Quebec must separate from Canada if there is to be a transfer of control over James Bay and the GRAND Canal to Cree grand chief Matthew Coon Come who is directed by Hill and Knowlton, the same giant American advertising agency who, controlled by the U.S. Joint Chiefs of Staff, created the public spin on the 1991 Gulf war. Allegedly, Coon Come hired Hill and Knowlton to direct his participation in the GRAND Canal project.

Turning Quebec against Canada and Natives against non-Natives is central to the new world order's water diversion resource control plans. Consequently, some big players were trained for these jobs.

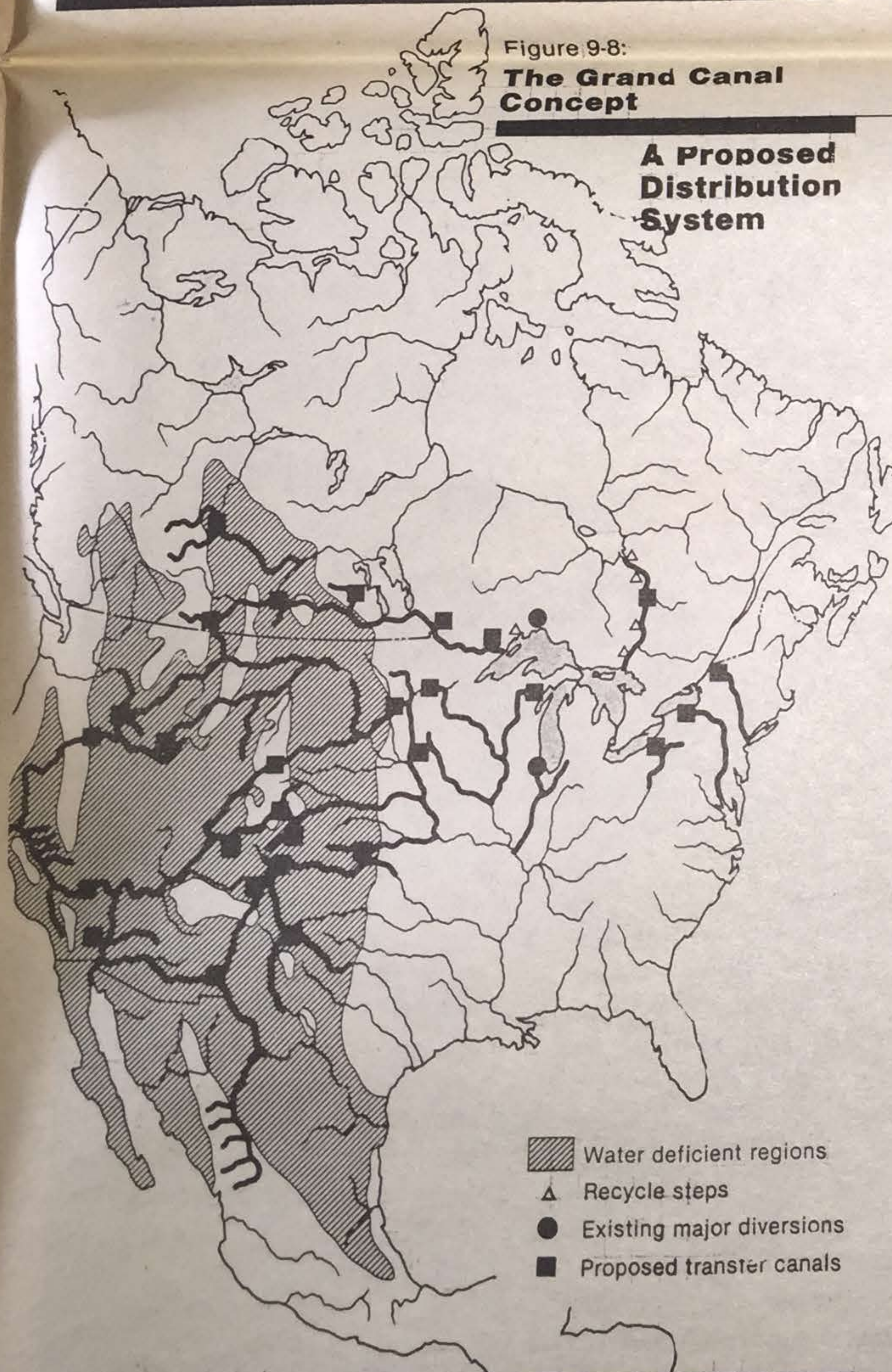

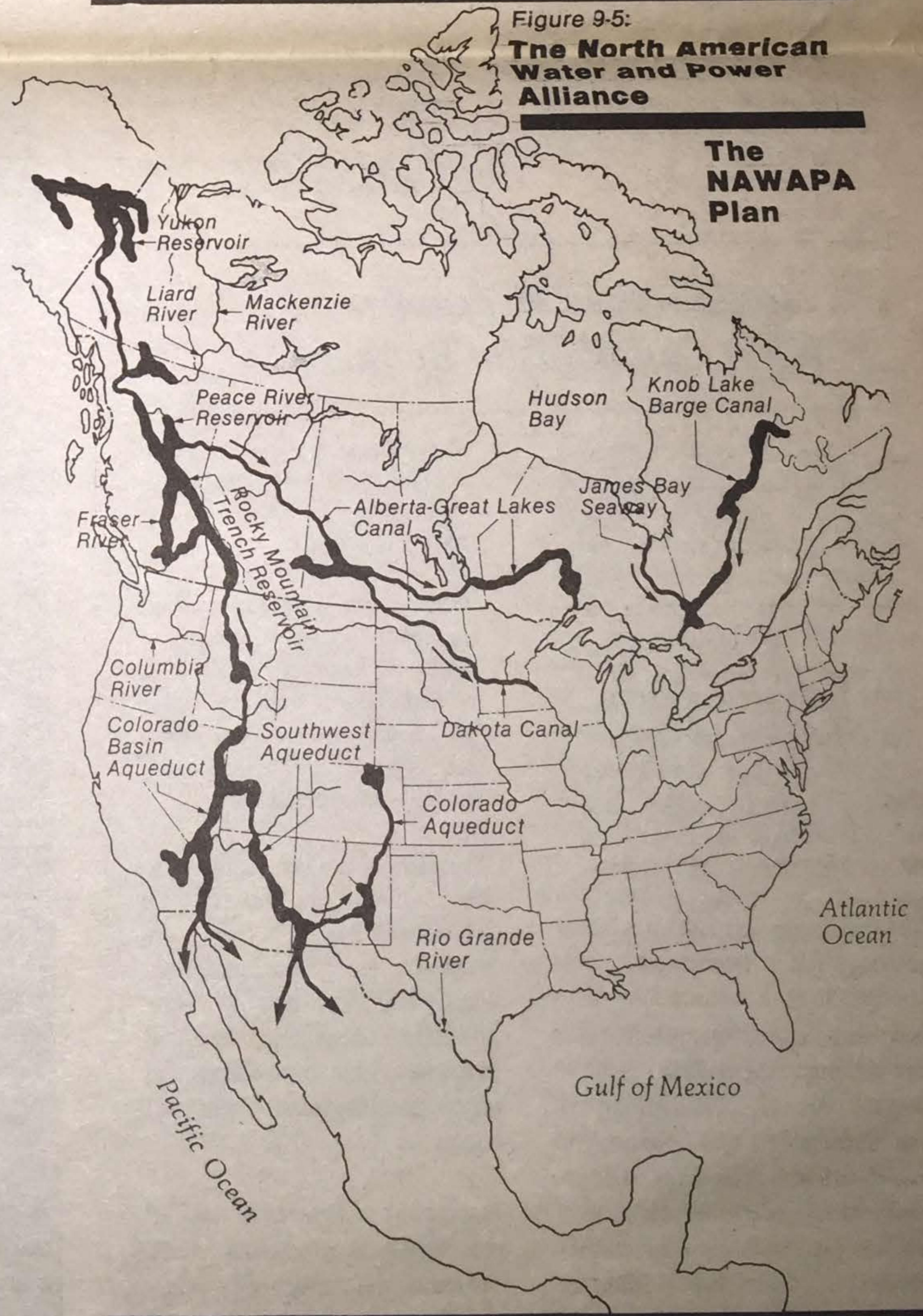

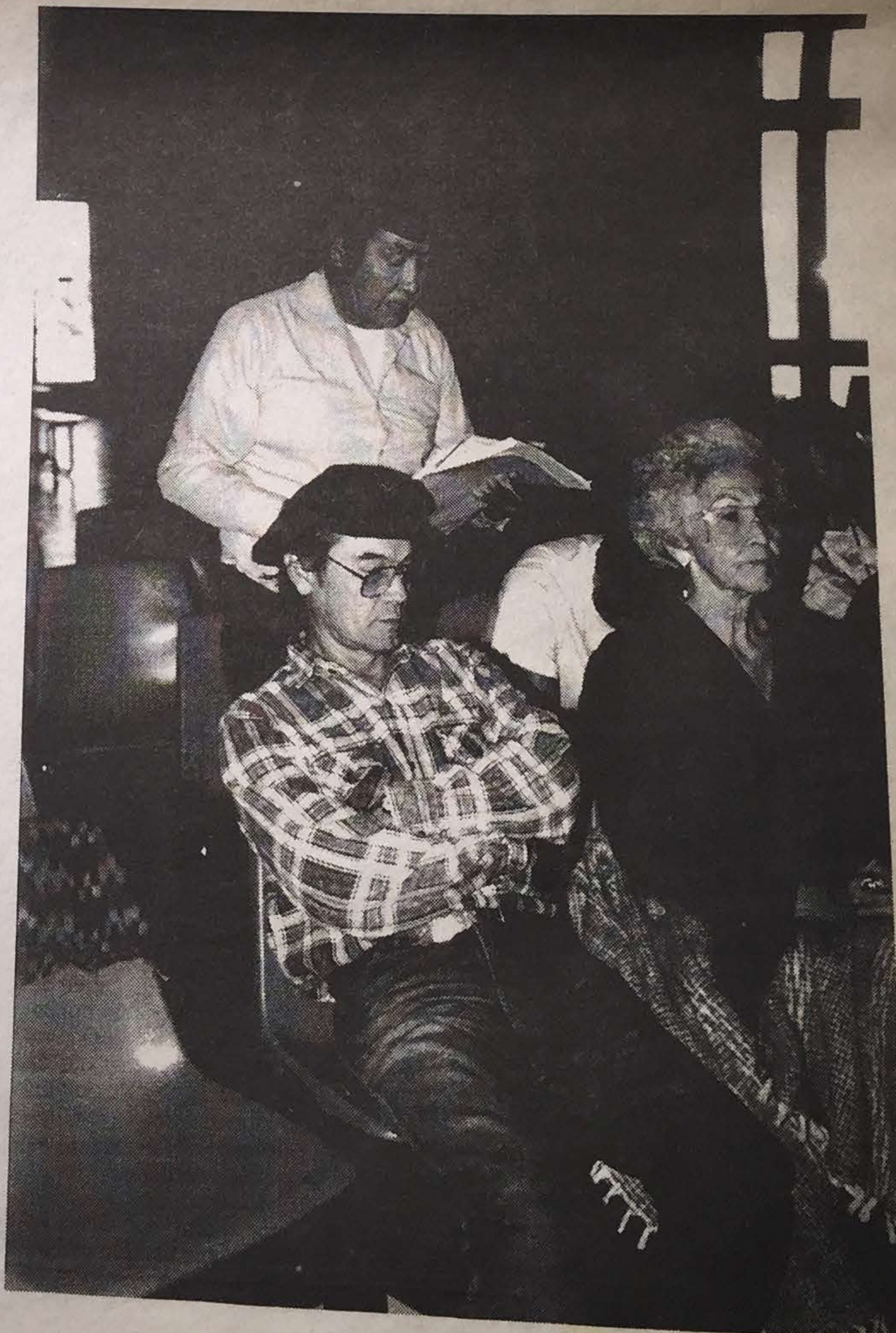

A Traditional Native Perspective

The ethno-biological continuity of life as our ancestors knew it is at the point of no return throughout the Pacific North West. The systematic alteration of the ecology in which our autochthonous cultures flourish correspondingly, inevitably and self-evidently entails the systematic destruction of the continuity of our human cultural identity—for the character of our human cultural identity is by definition dependent upon continuity of the bio-cultural identity of our forests.

Materialism and spiritualism are not opposing and antagonistic forces in our native culture. Rather, over the eons they have been reconciled in an equilibrium. That equilibrium is maintained by our paramount cultural value: respect. In our culture, the goal is to take from the material world enough to survive not only as physical beings, but also as spiritual beings. In contrast, we observe that in the non-native culture surrounding us enough is not enough. More is better. We observe that materialism and spiritualism are opposing and antagonistic forces in that non-native culture.

Our ancestors taught us that it was not our business to try and change what was already in place. Ours was to accept the world basically as we found it, and to leave up to Mother Nature and the Creator to educate this rapacious new race of people who are over-running our homeland. Our principle of respect meant that it was not up to us to dictate to the whites how they should live. Instead, our principle of respect led our ancestors to adopting a live-and-let-

live survival strategy with the transplanted race of Europeans who came to occupy our country. Respect means coexistence in a relationship of peace and friendship—with all beings and things—and, indeed there is no crucial difference between beings and things, for everything that exists is entitled to respect.

The Kings and Queens as the hereditary guardians of England, and on behalf of the transplanted race, agreed to conform with our principle of respect. As a matter of law, the respect was to be mutual and universal. The Royal Proclamation of 1763 confirmed for all time that "the several Nations or Tribes of Indians with whom We are connected and who live under Our Protection should not be molested or disturbed in the Possession of such Parts of Our Dominions and Territories as not having been ceded to or purchased by Us are reserved to them or any of them as their Hunting Grounds."

Today, we observe that in practice the respect paid to this agreed law has not been mutual. We gave our word. The whites gave their writing. We have kept our word. They have broken their writing. In terms of the Proclamation, we have not "molested or disturbed" the whites. But they have both "molested" and "disturbed" us. The crucial point, for legal purposes, is that this breakage was carried out, in practice, by local white governments which did not possess the jurisdiction to repeat or to amend the paramount

law enacted by the Imperial government. Thus, the breakage of the paramount law describe the fraud, treason and genocide committed by the legal and political establishment of local government rather than a change in that paramount law.

In consequence, the whites and their native collaborators are not so much governing us as attacking us—treating us as squatting trespassers in our own homelands, destroying our forests, killing our people. Under the smoke screen of crimes masquerading as federal and provincial laws, the whites are waging a war of physical and psychological intervention and attrition upon us. Systematically, we have been physically killed, infected with diseases, beaten, imprisoned, threatened and sexually preyed upon.

We are psychologically held up to contempt and ridicule, patronized, brainwashed, bribed, corrupted, threatened, and then criminalized for trying to defend ourselves. Their lawyers and politicians, who should uphold the paramount law, are effectively their generals and their police, their storm troopers in the

unrelenting campaign to take everything and leave us nothing.

Although it is all illegal, immoral and unjust, nevertheless the usurpation of our native jurisdiction to govern ourselves as a free people in a free land continues. Today, the white judges are the commandants of our concentration camps—the reservations onto which we are herded and from which we are forced to watch through the fence of chicanery, the invasion, clear cutting, pollution and tortured death of the body of our Mother, the earth, our home and native land.

By casting nets across the mouths of our rivers, the ancestors of the whites taught our ancestors they could break the continuity of our salmon runs, and starve us into submission. By having their priests and ministers promise us everlasting life they grouped us around churches, and thereby broke the cyclic patterns of our economy. By outlawing our "potlatch" ceremonies they broke the legal, economic, political and social ties that bound our people holistically as nations. By kidnapping our children and beating their native languages out of them in residential

and white schools they brainwashed our culture out of existence. By apprehending our children and giving them to whites they broke the family unit. By the whites' systematic removal or prohibition of alternative life support economies, native Elders have been made physically dependent for survival upon white social welfare payments.

In consequence, these Elders now live in constant terror that by speaking out against white tyranny, natives in general, including themselves in particular, will be deprived of the necessities of life. By training our children to be contemptuous of the ways of their parents, the white establishment inculcated in them a mirror image of the whites' sickness of racist ideology, thereby turning native against native.

By this means, genocide has been perpetuated to the point where today we stand at the brink of taking the plunge into the 'whites' final solution to the problem that we constitute for them by our very existence and persistence. Today, the problem still remains with the Indian Act system, with its network of nepotism, sycophancy to bureaucrats,

Ignace and his son. They are terrorists whose objective at Gustafsen Lake was to create a situation where one or more persons would be killed in a violent confrontation. It didn't matter who or how many people would lose their lives, just as long as blood was shed. I will never be able to support killing for any reason.

If supporting CIPI is a show of support for William Ignace then I would have to say no thanks.

Kealey is the former Hull area commercial developer who exposed the system of organised crime run by Mulroney's government and the complicity of the RCMP and justice system.

In 1986 Kealey was asked for a bribe by Public Works Minister Roch LaSalle,

who offered him government support for his project in exchange for 5% of all government contributions on top of the \$5,000 up front. Kealey successfully charged 16 people, including members of the government and RCMP, with criminal conspiracy.
