Tax Collection Agency created Canada in 1535

Hamath's Apiru-Trapezitae of the Hittites is now CCRA

At least as long ago as 3200 BC there lived a people known as the Hittites. Their King lived in a place called *Carchemish*, in the southeast corner of what is now Turkey. As with today's politicians the King's position was mostly cosmetic. He didn't have any real power.

Those with the power lived down the road a

ways, in a place called *Hamath*. The priests of Hamath had real power which they exercised from behind the scene, much as they do today. They created and owned the money supply and the banks (known then as money-changers).

The priests of Hamath wrote their language, now known as *Khitani*. They archived (hid) the peoples public records and promoted

How could they do 9/11?







known as legions. (Note the similarity that exists between the words "legion" and "religion" — both are places that allow grown men to practice brotherly love without drawing too much attention to that fact.)

Once the priests had encoded their plan for control over the West they published it as "open source coding" in a book called the

Bible (authorized at Nicaea by the pagan Greek military leader Constantine).

Making use of Freemasons known as the Knights Templar to set up a banking network throughout Europe, new cosmetic power over the West was then passed to the French monarchy, in the 14th century. True power to change or reverse direction was

retained by the high priests of "competing" Christian churches.

Furthermore, having taken ones money, he leaves, as one may wish him to do. He does not follow one down the road against ones will, and robbing one of more money as often as he finds it for his interest or pleasure to do so. He is too much of a gentleman to be guilty of such impostures, and insults, and villainies as these. Additionally, he does not try to dupe one into believing what he does is righteous and lawful. He is diametrically opposite to what you and yours falsely claim to be legitimate!

In order to properly understand what is happening today and why it happens, a knowledge of recent history in this country is mandatory. This is not to say that incidents similar to what has transpired in Canada have not occurred elsewhere in the world in one form or another. If one is not a "conspiracy theorist" then it must be admitted that there are just too many "coincidences" that occur to possibly be coincidental or accidental.

This rarely, if ever, happens. The final and most probable scenario is that we are dealing with brilliance and planning!

In 1844, Benjamin Disraeli, former Prime Minister of England is quoted as saying: "the world is governed by very different personages from what is imagined by those who are not behind the scenes."

In the early 1900's, the House of Rothchild (aka Bauer), were curious about certain facts concerning human behaviour, and in particular, how to control people. They approached the Tavistok Institute at Sussex University north of London, England. There it was learned that most people live in fear; fear of dying alone, fear of not going to heaven, fear of not being able to educate their children, fear of not having enough money to put food on the table, and many other things. Since that time, the political systems of the world have been constructed so as to perpetuate poverty and thereby assert control over the populations.

Laws, rules, regulations, bureaucratic red tape and taxation under

some pretext all contribute to this system of control by curbing the productive potentials of a people.

We all are taught in schools, which is reinforced by the media, that capitalists hate communism and communists hate capitalism. The truth of the matter is that capitalists see communism as a means to create and maintain a monopoly administered with typical capitalistic efficiency. Hence, globalization of industry and multi-lateral treaties which render ineffective any sovereignty of a nation. This is accomplished by a means known as progressive gradualism. Look around in this country and most "western" countries and one will find that most, if not all planks of the Communist Manifesto have been implemented. Central banks, public schools, gradual abolition of inheritance, no right to own property, progressive income tax, etc.

THESIS v **ANTITHESIS** equals the more favoured **SYNTHESIS**. SO WHERE IN RECENT HISTORY DOES THE FRAUD IN CANADA BEGIN?

The following is a brief, but accurate synopsis of contemporary history, and will be substantially increased and upgraded to a more professional level in the near future.

The "Fathers of Confederation" painting is a fraud. In that painting the Recording Secretary is depicted as one Hewitt Bernard and is confirmed in the accompanying adden-

dum. Upon consulting historical record, it will be found that the Recording Secretary at the Quebec Resolutions Conference of 1864 is not Hewitt Bernard, but is signed only by E.P. Tache. Mr. Bernard was not a delegate to the conference of 1864, nor was he in attendance.

So who is Hewitt Bernard? Again, record states that he was a clerk at Westminster in England. It happens that John A. Macdonald met and married Susan Agnes Bernard in London, England on February 16, 1867. Her brother, Hewitt Bernard first came to Canada from Britain in the summer of 1867, three years after the conference of 1864!

"CONFEDERATION" is also a fraud. This did not happen 1867 nor has it transpired since that time. The "British North America Act of 1867" did not confederate "Canada" nor is it a constitution, but is and was, an Act of British Parliament. This Act was merely an elaborate set of instructions via the Colonial Office for the then Governor General of the unified colonies known as Canada.

"CONFEDERATION" as defined by Dr. Maurice Olivier, K.C., Joint-Law Clerk, House of Commons, @ page 85 of the Special Committee Report on the BNA Act convened in Ottawa, February 26th, 1935: "A confederation is a union of independent and sovereign states bound together by a pact or a treaty for the common observance of certain

conditions dependent upon the unanimous consent of the contracting parties, who are free to withdraw from the union."

The key words here are "independent and sovereign" states. Nova Scotia, New Brunswick and East Canada and West Canada, (the Province of Canada) were not independent nor sovereign at that time, but rather were colonies of Great Britain, thereby making it impossible for any confederation to occur. This, in turn, is confirmed by the "Interpretations Act of 1889, Section 18, Paragraph 3:

"The expression COLONY shall mean any of Her Majesty's Dominions, (exclusive of the British Islands and of British India) and where parts of such Dominions are under both a Central Legislature and Local Legislatures, all parts under the Central Legislature shall for the purpose of this definition, be deemed to be One Colony."

Hence comes the expression the "Dominion (colony) of Canada".

The "Colonial Laws Validity Act" of June 29th, 1865 confirms the status of the above mentioned Provinces to be colonies and states in Section 6, the following:

"Any proclamation purported to be published by the authority of the Governor, circulating in any newspaper in the Colonies, signifying Her Majesty's assent to any such Colonial law or Her Majesty's disallowance of any such reserved bill as afore-

said, shall be prima facie evidence of such disallowance or assent."

Another strange anomaly is the fact that in the year 1272 A.D., a law passed in England forbade "any sheriff, lawyer, bailiff or any other of our Court constables" from holding public office. This was in theory, to separate the state from the judiciary. This law held for 600 years, until 1872. Apparently John A. Macdonald, Georges Cartier, and many others held public office illegally! Can you wager a guess as to which brotherhood belongs the credit for having this particular law repealed?

When John A. Macdonald was knighted by Queen Victoria and became Sir John A. Macdonald, it was reportedly stated that it was for "confederating" Canada. Obviously, that cannot be true. Another little known fact is that he became the Prime Minister without benefit of an election taking place, although he was leading political figure in power in what was then known as Canada East and Canada West, (the Province of Canada), prior to the summer of 1867. (Last election known to be held was in June 1863). Apparently, an election held between August 7, 1867 and September 20, 1867 confirmed his position as Prime Minister of the Central Legislature of the unified colonies known as Canada.

Other little known facts are that he (Sir John) was also continuously involved in real estate, land acqui-

sitions and rental property as well as being director of many companies. For at least 25 years, mostly while he was Prime Minister, he was: President of St. Lawrence Warehouse, Dock and Wharfage Company from Quebec City; and 1st President of Manufacturers Life Insurance Company of Toronto (1887). No conflict of interest there!!!

The foregoing statements constitute the following summary:

1. The Quebec Resolutions Conference of 1864 provided for a proposed Federal Union.

2. The Bill so drafted by the Canadian delegation to the London Conference of 1866 provided for a Federal Union.

3. The Colonial Office of the Imperial Parliament of Great Britain was not required to grant the colonies of Canada their request for a Federal Union.

4. The British North America Act carried out neither the terms nor the spirit of the Quebec Resolutions Conference.

5. Canada did not become a Federal Union nor a Confederation under the BNA Act, but rather a United Colony. Therefore, the privilege of a federation or a confederation was, and still is a prerogative of the provinces of Canada by virtue of the Statute of Westminster.

6. The parliament of Canada did not become the federal government of Canada by virtue of the BNA Act, but rather the central

legislature of a united colony, whose power was limited to assisting the governor-general as agent of the Imperial Parliament of Great Britain.

7. The BNA Act was and is not a constitution, but merely an act that united four colonies into one, with all authority still remaining with the British government. This Act created an ancillary corporation to "aid and advise" the Governor General to administer affairs in connection with the Provinces as long as they were colonies. The so created central legislature received its authority from the "Crown" and was not responsible to the elected MP's.


THE STATUTE OF WESTMINSTER
DECEMBER 11, 1931






What is the Statute of Westminster? This statute enacted December 11, 1931 gave the provinces of the Dominion (colony) of Canada their independence from British colonial rule. Since that date the provinces of Canada have been able to form any type of union they would so desire, whether a federation, confederation, a republic whatever the population did demand. To date, the provinces have not acted on their acquired status given them by the Statute, but have rather continued the ruse that we have somehow retained some form of non-existent link with the British monarchy. This in turn would involve the provincial governments of Canada

in an active role of conspiring to conceal treasonable practice, as they still participate in the governor-general lieutenant governor scam.

Section II of the above Statute states that notwithstanding anything in the Interpretations Act of 1889, no Province of Canada is longer a Colony therefore has no right to the position of Sovereign without political superior. This was confirmed in 1931 by Section 7 of the Statute of Westminster, graph 2, which states: "shall extend to the Provinces of Canada and to the provinces of the Dominion of Wales and the Town of Berwick."

The Statute of Westminster refers to the powers of the Dominion of Wales which reads: "No law made after the commencement of this Act by the Dominion of Wales shall be inoperative on the ground that it is repugnant to the laws of England existing on the 1st day of January 1901 of Parliament of the United Kingdom to any order or regulation made under an Act of Parliament and the Statute of Westminster include the repeal of such Acts or regulations far as they relate to such Acts."

By Section 7 of the Statute of Westminster

in an active role of conspiring to conceal treasonable practice, as they still participate in the governor-general lieutenant governor scam.

Section II of the above Statute states that notwithstanding anything in the Interpretations Act of 1889, no Province of Canada is any longer a Colony, and therefore has elevated each Province to the position of a Sovereign State without political superior. This is confirmed in the Act by Section 7, Paragraph 2, whereby Sovereign Rights "shall extend to laws made by any of the Provinces of Canada and to the powers of the legislatures of such Provinces."

The Sovereign Powers referred to are found in Section 2 of the Statute, which reads: "No law and no provision of any law made after the commencement of this Act by the Legislature of a Province shall be void or inoperative on the ground that it is repugnant to the law of England or to any existing or future Act of Parliament of the United Kingdom.. or to any order, rule or regulation made under any such Act, and the Powers of a Legislature of a Province shall include the power to repeal or amend any such Act, order, rule or regulation in so far as the same is part of the law of such Province."

By the above Sections of the Statute of Westminster, the British

Parliament binds not only itself but future Parliaments of the United Kingdom to recognize and respect the new status conferred by it upon the Provinces of Canada.

In order to confirm the above fact that Canada was a Colony of Great Britain until December 11, 1931, the same Dr. Maurice Olivier states that:

"Furthermore, our Constitution (BNA Act) is a law adopted by the British Parliament exercising its incontestable right of sovereignty toward its Colonies"

On page 125 of the same Special Committee Report of 1935, Dr. Beauchesne, KC., C.M.G., L.L.D., Clerk of the House of Commons is quoted:

"The Statute of Westminster has altered our status..."

Thank you, Dr. Beauchesne. The Statute of Westminster, literally overnight, did legally render the central legislature of a Colony of Great Britain into a non-entity! This non-entity status still exists to this day, contrary to the specious rhetoric we are asked to believe!

EMINENT DOMAIN ...WHAT IS IT AND WHAT DOES IT MEAN?

DEFINITION: From the English and American Encyclopaedia of Law:

"The unrestrained

ownership of land; independent of all action from without, paramount over all action within."

"The right to exercise the power of Eminent Domain is inherent in sovereignty, necessary to it, and inseparable from it. From the very nature of society and organized government, this right must belong to the State. It is a part of the Sovereign power of any Nation. It exists independent of Constitutional recognition, and it existed prior to constitutions. It lies dormant in the State, until legislative action is had pointing out the occasion, the modes and the agencies for its exercise."

Four hundred-fifty years before the dawning of the Christian era, Herodotus states that Kingdoms conquered by the Persians were required to bring to the Courts of Darius every year, a jar of earth and a jar of water; not for its intrinsic value, but as a token of subservience and acceptance of the laws of the Medes and Persians.

It is interesting that the British Empire held its Dominion and Colonies by similar exercise of this important right; for example: Nova Scotia was required to pay three Indian arrowheads per year. British Columbia paid two percent of all gold and silver mined. Manitoba, Saskatchewan and Alberta under the Hudson's Bay Company paid as follows:

"Yielding and Paying Yearly to Us, Our Heirs and Successors for the same, two Elks and two Black Beaver."

History notes that these payments to the Imperial Parliament ceased on December 11, 1931, thereby relinquishing forever the right of Eminent Domain over each Province separately and individually. Why does the supposed "parliament" in Ottawa pay that city rent? It's not called rent anymore, but rather a "grant". Perhaps too many people may become curious? It is, however, quite plain that the oligarchy who falsely claims to be a federal government, does not now, nor ever has had the power of Eminent Domain, which rather is a bare essential for any legal, sovereign entity. To be blunt, "parliament" owns not one square inch of soil in Canada, nor anything else! Apparently, the "duly elected" MP's are elected under the auspices of fraud, and are severally and jointly accountable for the perpetration of that fraud.



THE GOVERNOR GENERALWHAT WAS HE? WHAT IS HE/SHE NOW?

Any Governor-General to Canada was the Viceroy of the Crown, and was throughout time, appointed by "Letters Patent" issued via various agencies of the Crown, but always with its knowledge, permission and authorization.

James Murray, the first Governor-General, received his authority from the Board of Trade and Plantations. On March 23rd, 1931, the last Governor-General, Earl Bessborough, was accredited the same dictatorial power by the Crown in Chancery. Since the enactment of the Statute of Westminster, December 11, 1931, neither the Monarchy nor the Government of the United Kingdom have sent any authorized representative to Canada.

In 1940, an organization, the Native Sons of Canada, made an inquiry to the Department of Justice, Ottawa as to whether or not the present Governor-General is a viceroy of His Majesty, the King of England. The reply received from the Department of Justice reads:

DEPARTMENT OF JUSTICE
File: No. 5111-40
July 10, 1940

"The answer is that His Excellency the Governor-General came to Canada not in the capacity of viceroy of His Majesty, except in the popular sense of the term."

(Signed) J. Stuart Edwards Deputy Minister of Justice

Another inquiry in 1945 was made to Vincent Massey, Canadian High Commissioner in London by Mr. Frank Eliason, Secretary of the United Farmers of Canada, as to what Department of the Government of the United Kingdom was responsible for the appointment of the Governor-General to Canada. Replies were received from both the Canadian High Commissioner and the British High Commissioner, Mr. Earncliffe, from Ottawa. Neither of them knew, and referred the question to the Department of State for External Affairs, Ottawa.

DEPARTMENT OF STATE FOR EXTERNAL AFFAIRS

File No. 624-30 August 13, 1945

"No Department of the Government of the United Kingdom is concerned in any way with the appointment of the Governor-General to Canada."

At this particular point, one might note the differences in phraseology. "The Governor-General to Canada and the latter, the Governor-General of Canada. There is a distinct difference! Apparently, suppose Prime Minister MacKenzie King took it upon himself to issue his own "letters patent" in 1935, without authority from anyone to appoint his own Governor-General to Canada in order to carry on as if the Statute of Westminster had never been enacted and thereby perpetrate the fraud that we witness today.

Lord Tweedsmuir,

more commonly known as Mr. John Buchan, an author of several novels of fiction and ironically also a tax lawyer, could never have contemplated the fiction happening before his eyes when he was appointed Governor-General of Canada in 1935. protruding from his/her pockets.

What the "customer" is not told is the fact that the bank then considers the signed "promissory note" as a "loan" for the identical amount from the customer to the bank, whereby that same amount is then deposited to the credit side of the bank's ledger. Then, what is known as "cheque-book" money, (actually counterfeit) is created and transferred by the bank to the customer's account which creates a zero balance for the bank. In other words, the direction Bank of Canada takes is determined by two people, u n e l e c t e d , unaccountable and are not required to be Canadian citizens! Also, the Bank has its own "internal Audit Department".

The Bank of Canada was originally founded in 1934 as a privately owned corporation, and by 1938, the supposed "nationalization" of the Bank was deemed to have taken place whereby the Minister of Finance held the entire \$5 million share capital issued by the Bank. What kind of shares the "B" class or non-voting shares?

Another anomaly, (coincidence) is the fact that a certain Sir Thomas White, whose Marxist leanings were not unknown, was the key figure in the implementation of the *Income War Tax Act of 1917* and was also instrumental in the formation and s u p p o s e d nationalization of the Bank of Canada. One may recall that central banks and a graduated income tax are key planks in the C o m m u n i s t Manifesto. Dr. Skelton, the "father" of the Department of External Affairs is also known for similar ideals.

The "Income War Tax Act of 1917" was instituted under the War Measures Act and is at least of dubious legality. It should have been more properly named the "Bank Interest Debt Income Tax Act", but, as those that are realized this would not "fly", relied upon the exigencies of war and patriotism propaganda to ensure its passage. My, how the gears mesh!

Let me now shift to another related area, and that would be the *Bank Act of 1913*. The similarities between our "Bank Act" and the "Federal Reserve Act" in the United States is yet just one more "coincidence"

that occurred within six months of one another. Both of these "acts" are essentially the same as they give the custody of the central gold reserves and issuance of currency to private financial monopolies. It is not the *Bank Act* itself that confers authority to the private banks to issue currency, but rather Section 124 concerning the "*By-laws of the Canadian Bankers' Association*". This association, in 1900, "humbly prayed to Parliament" to be incorporated, and in time was given that incorporation. The question that would obviously arise is "Why would an association in 1900 want to be incorporated?" The theme of p r o g r e s s i v e gradualism is at work again, and the year 1913 proves the answer.

ACTS of the PARLIAMENT of the DOMINION (Colony) OF CANADA

THIRD AND FOURTH YEARS OF THE REIGN OF HIS MAJESTY KING GEORGE V.

Being The SECOND SESSION OF THE T W E L F T H PARLIAMENT Closed by Prorogation on the Sixth day of June, 1913

Section 124. The Association may make by-laws, rules and regulations respecting (a) all matters relating to the appointment or removal of the curator, and his powers and duties.

(b) the supervision of the making of the note of the banks which are intended for circulation, and the delivery

thereof to the banks;

(c) the inspection and disposition made by the banks of such notes;

(d) the destruction of notes of the banks;

(e) the custody and management of the central gold reserves and the carrying out of the provisions of this Act relating to such reserves; and,

(f) the imposition of penalties for the breach or non-observance of any by-law, rule or regulation made by virtue of this section.

At this particular point in history, it is fair to say that the Central Legislature of the United Colonies (Dominion) of Canada, has forsaken its sole and sovereign right as outlined in the BNA Act of 1867, for the creation of credit (money) to the private banking system and thereby becoming subservient to that private monopoly. The words of Mayer Amschel Bauer ring true!

Liberal leader Mackenzie King made the following remarkable statement as his platform of re-election in 1935:

"Once a nation parts with the control of its currency and credit, it matters not who makes the nation's laws. Usury, once in control, will wreck any nation. Until the control of the issue of currency and credit is restored to government and recognized as its most conspicuous and sacred responsibility, all talk of the sovereignty of Parliament and of democracy is idle and futile."

THE STANDING COMMITTEE REPORT ON BANKING AND COMMERCE 1939

These proceedings cover some 856 pages of evidence given by Graham Ford Towers, the first Governor of the Bank of Canada. Most of the evidence so given was the result of questions posed to Mr. Towers by Mr. G. McGeer, K.C., former mayor of Vancouver. There is something, however, that is most perplexing and that is the fact if one looks for and finds the minutes of these proceedings in the archives in Ottawa, the pages number only some 230 plus. The question remains, where did the other 626 odd pages disappear to?



I am in possession of a notarized copy of the former, and have read both of these volumes. The dates, times, and members of the Committee are identical. The latter volume when compared to the former, is nothing to be better described than gibberish!

It is obvious even to the untrained eye that the latter report has been intentionally dis-

Broadly speaking, all new money comes out of a Bank in the form of loans.

As loans are debts, then under the present system all money is debt. (p. 459)

Q. When \$1,000,000 worth of bonds is presented (by the government) to the bank, a million dollars of new money or the equivalent is created?

Mr. Towers: Yes.


Q. Is it a fact that a

million dollars of new money is created?

Mr. Towers: That is right.

Q. Now the same thing holds true when the municipality or the province goes to the bank?

Mr. Towers: Or an individual borrower.



Q. Or when a private person goes to a bank?

Mr. Towers: Yes.

Q. When I borrow \$100 dollars from the bank as a private citizen, the bank makes a bookkeeping entry, and there is a hundred dollar increase in the deposits of that bank, in the total deposits of that bank?

Mr. Towers: Yes. (p. 238)

Q. Mr. Towers, when you allow the merchant banking system to issue bank deposits which, with the practice of using the cheques as we have it vogue today, constitutes the medium of exchange upon which I think 95 per cent of our public and private business is transacted, you virtually allow the banks to issue an effective substitute for money, do you not?

Mr. Towers: The bank deposits are actual money in that sense, yes.

Q. In that sense they are actual money, but, as a matter of fact, they are not actual money but credit, bookkeeping accounts, which are used as a substitute for money?

Mr. Towers: Yes.


Q. Then we authorize the banks to issue a substitute for money?

Mr. Towers: Yes, I think that is a very fair statement of banking. (p. 285)

Q. 12 per cent of the money in use in Canada is issued by the Government through the Mint and the Bank of Canada, and 88 percent is issued by the merchant banks of Canada on the reserves issued by the Bank of Canada?

Mr. Towers: Yes.

Q. But if the issue of currency and money is a high prerogative of government, then that high prerogative has been transferred to the



extent of 88 per cent from the Government to the merchant banking system?

Mr. Towers: Yes. (p. 286)

Q. WILL YOU TELL ME WHY A GOVERNMENT WITH THE POWER TO CREATE MONEY, SHOULD GIVE THAT POWER AWAY TO A PRIVATE MONOPOLY, AND

THEN BORROW THAT WHICH PARLIAMENT CAN CREATE ITSELF, BACK AT INTEREST, TO THE POINT OF NATIONAL BANKRUPTCY?

Mr. Towers: If parliament wants to change the form of operating the banking system, then certainly that is within the power of parliament. (p. 394)

Q. So far as war is concerned, to defend the integrity of the nation, there will be no difficulty in raising the means of financing, whatever those requirements may be?

Mr. Towers: The limit of the possibilities depends on men and materials.

Q. And when you have an abundance of men and materials, you have no difficulty, under our present banking system, in putting forth the medium of exchange that is necessary to put the men and materials to work in defence of the realm?

Mr. Towers: That is right. (p. 649)

Q. Would you admit that anything physically possible and desirable, can be made financially possible?


Mr. Towers: Certainly. (p. 771)



THE GUERNSEY EXPERIMENT

After the end of the Napoleonic Wars in the early 19th Century, the Island of Guernsey was in dire straits. Apart from its mild climate, there was precious little to attract visitors or to keep the inhabitants from moving to the mainland. There was no trade or any hope of employment for anyone. Roads were practically non-existent and the town was in shambles. Vast tracts of land were about to be taken by the sea because of the sorry state of the dykes.

In 1815, a Committee was formed to examine the matter. It was found that further taxation on the impoverished island was impossible. The alternative of borrowing money from the private banks would incur debt charges at a high rate of interest. It

was also clear that even though they would pay interest charges for years, the "loan" which would consist of an entry in a book of account, could never be repaid.

Finally, after much grave deliberation, the Committee reported in 1816 that the issuance of "debt-free" State Notes was the only possible way to alleviate the present intolerable conditions. In 1817 and over the first few years there were roadblocks set by the private banks, but in time these were overcome with no detriment (to the State).

Today, the Island of Guernsey has a negligible rate of taxation, no unemployment, no inflation, good roads, fine buildings, good dykes and no welfare thanks to the implementation of the simplest type of monetary reform; **COMMON SENSE!!!**


Surely, with all our "brilliant economists", we could devise a system whereby money could be issued as required without having to resort to "interest debt" and usury. This has been done before in a town in Austria, and another town, Swanenkirchen, in Bavaria. These towns were transformed temporarily from poverty-ridden to prosperous communities by the above stated means, but were forcibly prevented from issuing further money by their respective bank-controlled government.

I am writing in relation to your appeal from the decision of the Review Tribunal held at Ottawa, Ontario and rendered on March 12, 2001. If you have a representative, you may wish to contact him/her prior to taking any action in this matter.

As a result of a review of medical information on file, the Department's administration is now satisfied that you were disabled within the meaning of the *Canada Pension Plan* when you last met the contributory requirements in December, 1992.

Nevertheless, subsection 42(2)(b) of the *Canada Pension Plan* provides that the earliest a person can be deemed disabled is 15 months prior to the month their application for a disability pension was received. Accordingly, the earliest you could be deemed to have become disabled is April, 1998, based on your application of July, 1999. I have, therefore, been instructed to offer you a disability pension with the effective date of onset month of April, 1998. Pursuant to section 69 of the *Canada Pension Plan*, the commencement of payment would be August, 1998.

If the foregoing offer is acceptable, would you please date and sign the enclosed Consent to Judgment, in duplicate and in the presence of a witness, returning both forms to this office. As this matter is scheduled to be heard by the Pension Appeals Board in Ottawa, Ontario on October 17, 2001, we would appreciate receiving a response at your earliest opportunity. 


