## WOLVERINE IS NOT GUILTY

### What really happened at Gustafsen Lake?

Today, the truth is finally being told. Why? Because "they" are preparing the case to go to a jury trial where there can be no more lies and no more propaganda from the RCMP and the CBC. The true story about what really happened at the Gustafsen Lake standoff in B.C. will finally be made clear.

Recently, the RCMP was forced to reveal what actually took place at the B.C. Native standoff during the months of August and September '95. The legal disclosure came in the form of "will say" statements released by Lance W. Bernard, Deputy Regional Crown Counsel, in the Ministry of the Attorney General of B.C.

What initially strikes a knowledgeable reader is how the police lie by omitting important evidence. They illegally, although some may say cleverly, omitted a small but very crucial detail from their public statements to date. Nonetheless, it is a piece of legal evidence that is key to proving William Jones Ignace's innocence.

As far as we know, the RCMP have never told anyone about how their own researcher, a serving member of the force, had concluded as early as last July, that Shuswap Natives had every right to be at Gustafsen Lake, simply because they were, in fact, "on their land". The CBC apparently also conveniently forgot to remind

Canadians of this little known fact. Land theft, even by government, is still illegal in this country. And, to this very day, Canada has not passed a Statute of Limitations to protect land thieves. Much to the dismay of the JUST-US SYSTEM, the RCMP officer in question, was secretly video taped by the camp residents, as he carefully explained to Splitting the Sky, the explosive conclusions contained within the secret report he had recently prepared on the Shuswap land claim in question, for RCMP Commissioner Murray.

time reader, is not a pretty one. It exposes a frightened police force that had lost its nerve and was bent on killing. Although the police were protected from any harm by the thick steel plates of a military Bison, numerous police officers are shown to have acted out of fear. In fact there are just too many comparisons with the Randy Weaver case in Idaho, to be a coincidence. So much so that ineffective or inadequate training must be at the root of the lack-of-discipline problem.

The statements made by the police reveal how at 2:00 p.m., on September 11, 1995, a red truck from the Gustafsen Lake native camp crossed over a land mine buried earlier on the road by the military. When the mine exploded, two passengers, one white and one native, bolted from the truck and ran unarmed into the nearby lake in an attempt to swim back to the camp.

Subsequently other RCMP officers, all protected from the complete safety of a military Bison, circled the lake and began shooting at the swimmers. In response, shots were fired from the woods towards the Bison, in an attempt to distract its occupants. As a result of looking towards the source of the distraction, the Bison's military driver saw a man walking close-by whom he claims was Wolverine. The soldier was immediately ordered to "eliminate him", by Constable Sean Maloney of the Agassiz RCMP Detachment.

The military driver, Steven Andrew Bidwell of Canadian Forces Base Calgary, then attempted to run down and kill Wolverine, an old age pensioner, by running over him with the Bison under his command. At one point, he claims to have driven to within four feet of Wolverine when three tires were blown out from under his vehicle. It is surmised that

only because of their expert marksmanship, were Jonesy's friends and family able to shoot the tires and save his life.

## David beats Goliath ....again

David, you will remember, is the fictitious name used by a police informant who helped break up a major drug ring in Ontario, only to suffer fire damage to his home in an obvious case of arson, as well as the theft of most of his personal belongings, in 1988.

Following a ten day trial last October, one prosecuted by David personally, with the assistance of Glen Kealey another non-lawyer, the Judge eventually ruled in David's favour and against Pilot Insurance Company. Pilot Insurance, for seven long years, had refused to pay any part of David's original insurance claim for the theft. Pilot Insurance claimed instead that he had set the fire.

The civil case became a model case for just how Canadian courts function to service the insurance industry's needs. Although David's claim was backed with over 6,000 pages of documentary evidence he accumulated over the seven year period, in his judgement, Judge Jenkins, specifically made mention that punitive damages were not being awarded in this case. Then, the Judge went on to award David the minimum amount possible (\$25,500) and added that this money was due back to 1988, with interest. Afterwards, Pilot Insurance Company lawyers immediately claimed they were liable only for the payment of simple interest, instead of the compound interest that they, themselves, have earned on the funds they set aside for the unpaid claim, since 1988. The lawyers are

Can anyone possibly imagine the extreme pain suffered by grandparents who receive a heart-wrenching letter such as the one quoted on page two - **THIS LETTER WAS OBVIOUSLY DICTATED BY THESE CHILDREN'S PARENTS?**

Steven Andrew, Chairman, National Family Law Section of the Canadian Bar Association and Liberal Justice Minister Allan Rock certainly don't care. Andrew, in his letter of September 18, 1995, written at the request of Allan Rock and sent to Warren Allmand, the former Chairman of the Commons Justice Committee states **"The Bill should therefore be defeated"**.

## LIBERALS and BLOC JOIN FORCES TO KILL the BILL

This undemocratic, cruel and dictatorial order guaranteed a lifetime of heartbreak for thousands of caring Canadian grandparents and grandchildren. By killing Bill C-232 in Committee, "our" politicians also assured that more and more Canadian grandparents will be receiving similar heart wrenching letters.

Bill C-232 was a private member's bill presented to the House of Commons Justice and Legal Affairs Committee by Reform Party, M.P., Daphne Jennings. Bill C-232 was an act to amend the Divorce Act (granting access to, or custody of, a child by a grandparent). In a statement to the Justice Committee, Jennings explained that "the main purpose of Bill C-232 is to fill a void in the Divorce Act in the area of access and custody."

At present only parents of a child are allowed to discuss access and custody in a court of law in the case of divorce. The practical effect of this is that grandparents who may have actually been raised solely by the grandparent(s) - have no automatic right of standing in court." One part of the Bill would have also given grandparents who have a right of access, a right to make inquiries and to be given information as to the health, education and welfare of the grandchildren.

On December 7, 1995 Bill C-232 was defeated. This is a day that grandparents in Canada will never forget. To Madeleine and David Bremner of Ottawa (not the grand-

parents who received the letter quoted above), this meant that all of their hard work over the past five years had been "for naught". All of their hopes and dreams were crushed that fateful day. Bill C-232 had become their lifeline, their "raison d'être". It was not bad enough that they had lost their daughter through a tragic unexpected death, now they had also lost access to their two grandchildren. They were the only link they had left to their beloved daughter.

The Bremners' tragic story began when their son-in-law began a serious relationship with another woman (whom he eventually married). Approximately one year after their daughter's death the Bremners contacted their son-in-law at the beginning of the summer holidays to ask him if he would be bringing the children to visit with them in Ottawa. He told them that he and the kids would not be coming. When the Bremners replied that they would travel to Nova Scotia - the son-in-law made no comment.

This did not strike them as strange. They were so anxious to see their grandchildren that they paid no attention to their son-in-law's sudden cool treatment and went ahead with their plans to travel to Nova Scotia. When they arrived, to their amazement they were never allowed to be alone with their grandchildren. They were under supervision at all times. It soon became obvious to them that the children were also under a strict censorship never to speak about their mother.

The Bremners, who had planned a two week visit, were absolutely shocked and left speechless when, after a few days, they were more or less told by their son-in-law to go home. ".....you're no longer my inlaws." Little did the Bremners know that this was to be the last time they would ever see or speak to their

grandchildren. Shortly after this incident, the son-in-law remarried and the new wife adopted the children legally. The Bremners were never notified of the adoption and because of it, overnight, they lost all access to their two grandchildren.

From that moment on their lives would never again be the same. All Birthday, Christmas and Easter cards and gifts have never been acknowledged. This is allowed only

available to them. They even created their own support group known as "GROWTH" Grandparents'/Grandchildren's Right of Wholesomeness Through Heritage.

The Bremners' research eventually led them to a network of grandparents across Canada who suffer from the same fate. They joined forces and together managed to bring a new awareness about the problem to attention of the general public.

because of the flaws that exist in our present judicial system. To their horror the Bremners discovered that "one day you can be a loving, caring grandparent and the next you're not. Overnight your legal status disappears."

During the past 5 years, the Bremners have been tireless in their search to find a way to re-open the door that was so cruelly and callously shut on them and their grandchildren. They have looked at, and have tried every possible venue

A courageous Reform Party M.P., Daphne Jennings, took on the thankless task of battling Canada's Legal Industry. This is an industry that has been dubbed "The Just-Us system", because it cares only about the billions of dollars they can generate for themselves each year under the present rules. These are the billions of dollars that they so callously "steal" from naive middle-class Canadians. Apparently, they do it mostly out of greed and avarice - for the almighty \$.

You can now begin to understand why the Minister of Justice and the Canadian Bar Association ordered the "silent defeat" of Bill C-232 in Committee. ## Book says key spy was a Rothschild

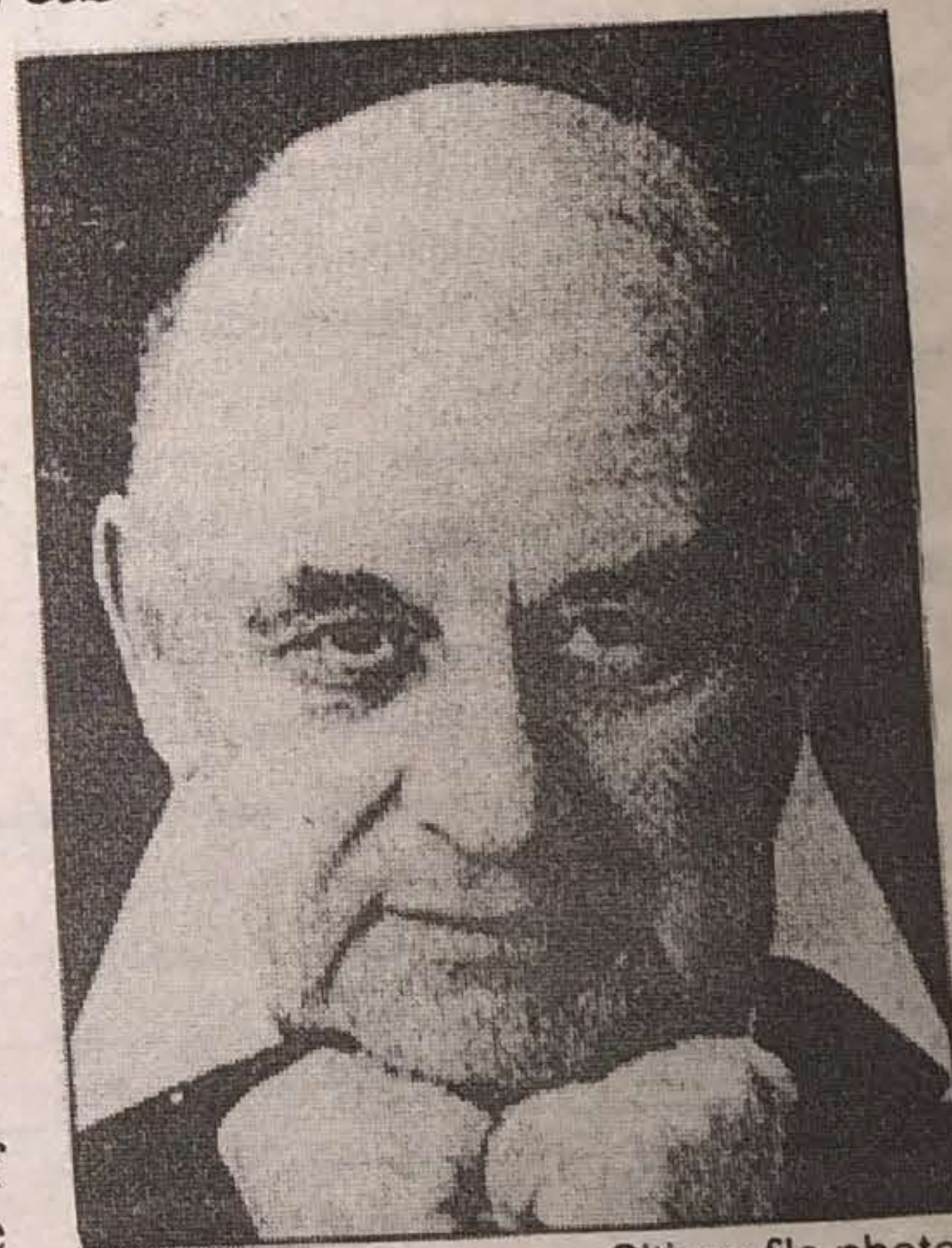
LONDON — Lord Rothschild, a scientist and member of the famous banking family, was the mysterious Fifth Man in the Soviet spy ring headed by notorious double agent Kim Philby, a book being published this month alleges.

The Fifth Man, by Australian journalist Roland Perry, asserts Rothschild, who died in 1990, escaped suspicion that he could have been a member of the famous Cambridge University ring of spies by using his considerable wealth and influence.

The motives and methods of the upper-class spy ring have fascinated the world for decades. The names of Harold (Kim) Philby, Anthony Blunt, Guy Burgess and Donald Maclean are virtually synonymous with spying and treachery, but the identity of a possible fifth member of their circle has never been confirmed.

Former British civil servant John Cairncross has been named several times as the Fifth Man.

Perry, who details how he spent years trying to track down the identity of the missing spy, dismisses the notion Cairncross

was the much sought-after agent.

Perry said he gained many of his clues from KGB masterspy Yuri Ivanovitch Modin, who claimed to have controlled many British agents during the long years of the Cold War. He said Modin did not name Rothschild but gave him enough information to narrow the field.

The book is to be published by Macmillan on Oct. 21.

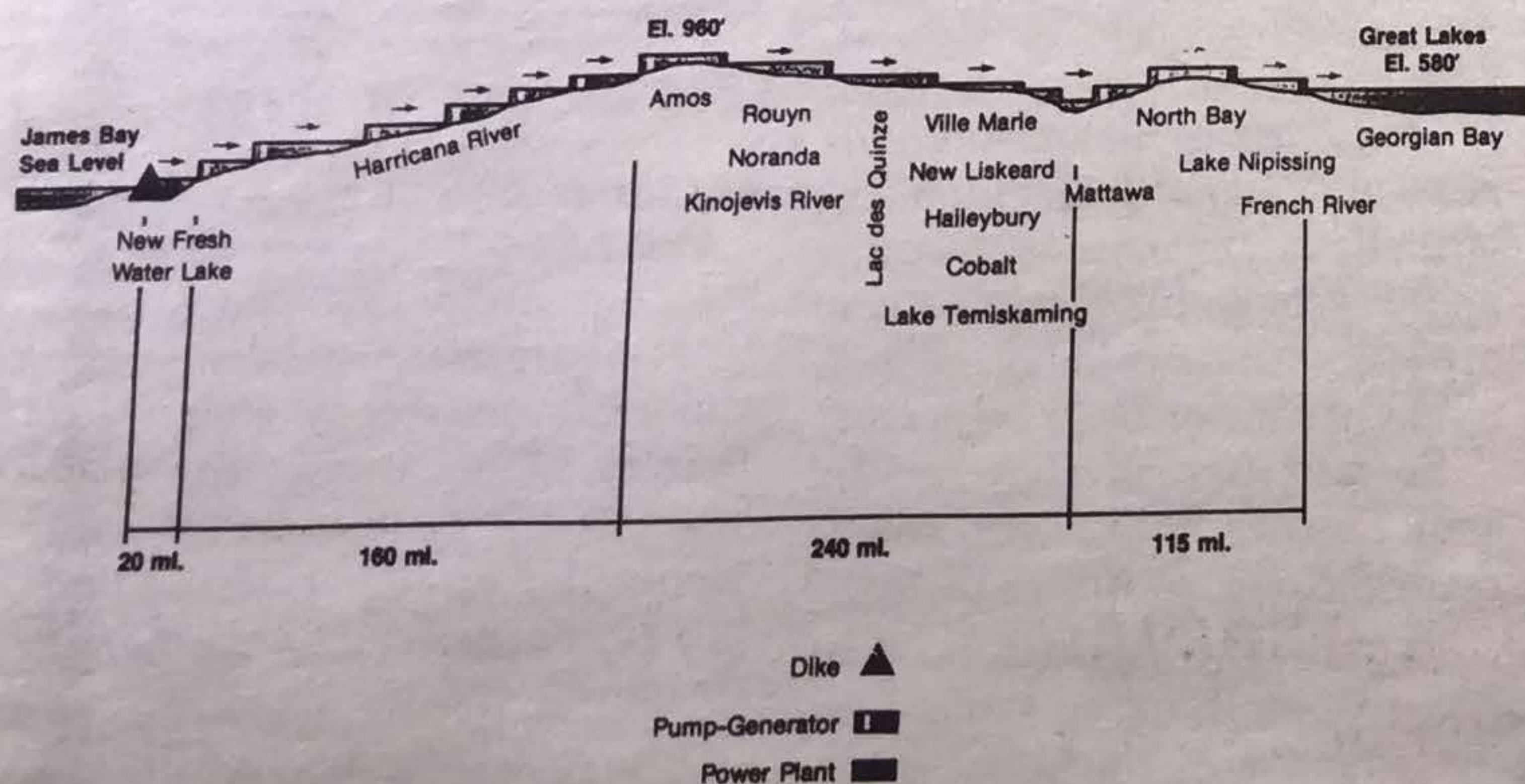

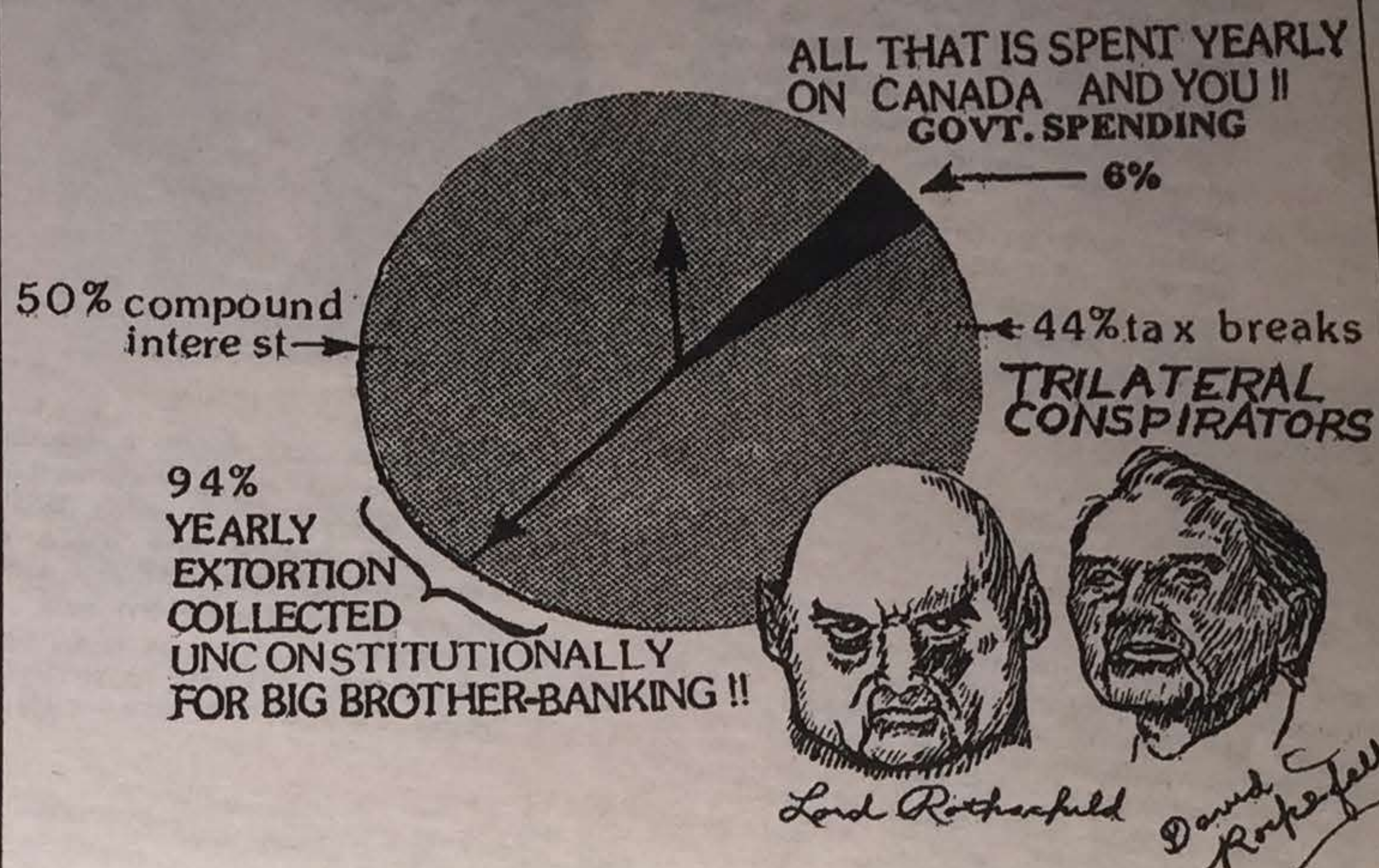

chess was first played, in India. Now, let's follow the money trail instead of the Bible.

Egyptian Pharaohs had controlled the whole known world up to that point in its "civilized" history. This meant they held control over Africa and India, as well as, the entire Middle East. A millennium earlier they had built the pyramids to contain their remains after death (at Alexandria the Phoenix built the first pyramids). When Pharaohs died they wanted to be surrounded by the riches they had accumulated during their life time. These riches consisted of gold, pharmaceuticals (ie. mir, a pain killer and embalming fluids) along with occult supplies (such as incense used in spiritual ceremonies; because they also believed they were Gods and, at death, would rise to heaven like smoke).

To a detective following the money trail, it would make more sense to believe that Moses was directed, knowingly or unknowingly, by the Phoenix, (the Pharaoh's wise men - they were the scribes who often dressed as women, whose job it was to count and control the Pharaoh's cash as well as preserve the wisdom contained in the 500,000 or so manuscript archive that resided

within their library, at Alexandria). Moses may have been told to lead the Hebrew slaves, slowly, across the Sinai, as a diversionary tactic. In our view, this would have been done to cover-up the simultaneous looting that was going on, by the Phoenix, of the Pharaoh's treasures including the accumulated wisdom that was handed down from generation to generation over millennia. The contents of the library and vaults would have been moved over time, to Phoenicia. Later, arson, set by the Phoenix at Alexandria's now empty library, would cover their tracks - their "original" sin.

It is from that point in time that Egypt and the Pharaohs began their decline. Coincidentally, we are taught that world power and trade simultaneously and gradually, shifted to Phoenicia, to an area now occupied by Lebanon, Syria and also, southern Turkey. It was from this region that raiding armies came, in the seventh century BC, to destroy Solomon's first Hebrew temple built in Jerusalem and exiled the twelve Hebrew tribes, during the period known as the diaspora - thereby dispersing the only incriminating witnesses to the earlier theft that occurred at Alexandria.

Egyptian mythology, is a bird sacred to the sun, reborn from the ashes of the funeral pyre which it made for itself. It is a fabulous, large, stork-like bird, originating in Ethiopia. It also is described as being "bright-coloured", due to its gorgeous plumage and having a "sweet voice". Furthermore, it is always male, the only one of a kind (a CEO).

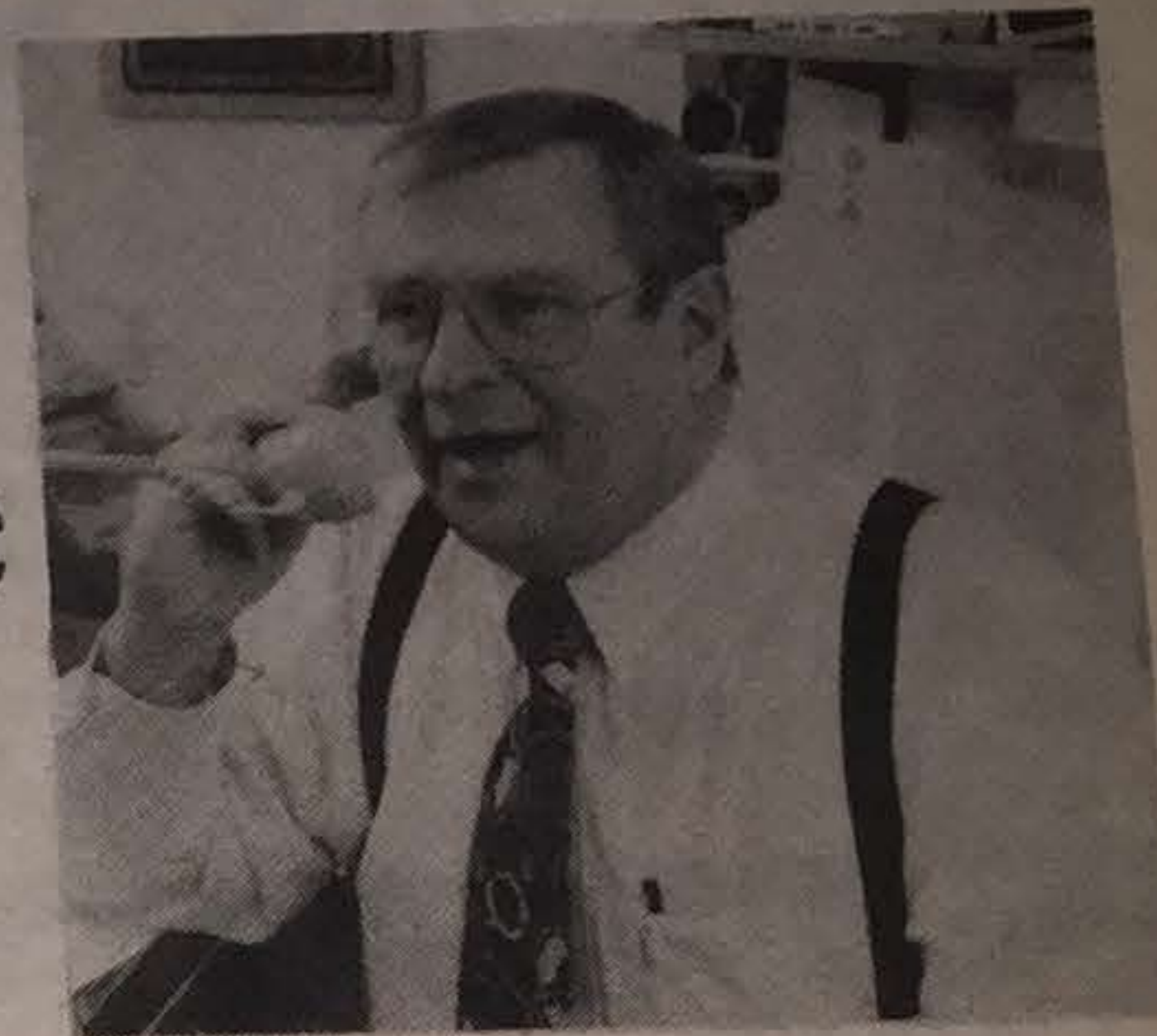

## ASK HERBIE A QUESTION

"HEY! HERBIE, HOW DO INSIDERS DEAL WITH TROUBLESOME WHISTLE-BLOWERS?"

INSIDERS are openly secret political societies such as the Royal Institute on International Affairs, the Council on Foreign Relations, the Trilateral Commission, Club of Rome, Knights of Malta, B'nai B'rith, Freemasons, A.D.L., Bildebergers, J.D.L., Round Tables and the Olympians...etc. These secret societies normally operate openly through transnational corporations, tax-free charitable foundations, insurance companies, government, universities, banks and the national media.

### A Letter to Preston Manning

Dear Preston,

I had a discussion recently with Harry about Shelley Ann Clark, the woman who claims that, during her employment with the Mulroney Government, she had some upper-level dealings with the paperwork regarding the FTA (Canada-U.S. Free Trade Agreement). If the paperwork is brought out from the archives where it is purportedly being stored, and examined by experts in trade law, then the matter can be put to rest as to whether or not Ms. Clark's allegations are true and her concerns well-founded.

As your constituent, I would ask that you please request the disinterment of these documents so that they may be examined to ascertain the validity of Ms. Clark's allegations.
