

RED CROSS LIARS

Don't blame the jury for finding Andrew Hardy guilty of mischief. Blame the pathological liars who manage the Red Cross blood collection and the liars in the media who cover up for them (on behalf of the bigger liars who control the JUST-US SYSTEM — the international bankers who pull both their strings).

As usual, the Red Cross needed to shift blame. They only care about profit, not responsibility. They caused Andrew Hardy to be arrested without a police investigation into his side of the story. Why? For no other reason than to cover-their-own-asses.

In December 1994, Dr. Lesley of the Red Cross blood clinic in Ottawa responded to a call from Andrew Hardy, who took exception to the Red Cross lying on TV about the safety of blood screening. Lesley thought Hardy was a reporter. He said so in a memo to his boss Dr. Giulivi and in a statement to the police, both written at the time of the occurrence.

His boss, Dr. Giulivi, is just one of the many incompetents within Red Cross management that the *Globe and Mail's* Geoffrey York attempted to describe,

in an article published in 1993. These managers were positioned to replace more competent staff at the Red Cross. Unknown to them they would be the fall-guys. They would, eventually, be taking the blame for their superiors and government mandarins — for people like Judge Krever, the judge who, currently, is managing the cover-up of his own involvement and alleged criminal behaviour in regards to Canada's blood distribution system.

When questioned, Giulivi responded to Hardy's cross-examination by lying. "You had identified THE flaw in the system", he stated, diverting attention away from himself and his superiors.

The trial judge, a rookie appointed not for his mental capacity nor for his grasp of the English language, but rather, as a reward for years of kissing babies and faithful attendance at cocktail parties held to raise the political profile of the Liberal Party, allowed the lie to go unchallenged. The jury had no option but to accept it. As a result, blame was cast upon unsuspecting blood donors for all past Red Cross negligence and criminal activity — most, in fact, being the result of the mismanagement of Canada's criminally lax blood collection and distribution system.

Did the judge know differently? Did he know Giulivi was a liar? Yes he did. The crown attorney, David Stewart, (another political hack married to a Liberal federal cabinet minister), was brought in from out-of-town to assist the judge in rail-roading Hardy. Stewart was a "hired gun" in this so-called "priority case". He knowingly presented Giulivi's false list of credentials to the court. The Doctor's long, imaginary CV was entered as an exhibit by the judge.

But there was a problem with the CV. As part of the evidence disclosed to Hardy was a statement written by Dr. Giulivi, a full fourteen months after the telephone conversation between his direct subordinate Dr. Lesley and the accused Andrew Hardy. Giulivi's first statement on the matter proves one thing conclusively. Giulivi lied about his credentials contained in his CV.

Dr. Giulivi claimed to be the author of a number of highly acclaimed articles on very technical information about blood — the problem with that — the doctor can't write worth a dam. He can't even construct a simple sentence. His written statement to the police proves it. However, the trial judge never allowed Hardy to enter the

LIVE REALITY NOT ILLUSIONS

I am one passionate Canadian in search of truth and wisdom.

To date, because of my personal observations and detailed analysis of these observations, I conclude beyond any reasonable doubt, that all political systems of the world are totally corrupt.

Fascism is a system bankers use to control people by means of the military and police. An example of Fascism today is the Gustafson Lake Native Standoff and the resulting trial. I have attended this trial in Surrey, B.C., since July. Later, we will discuss how many of the elements of this case resemble tactics one would only expect to observe in a Fascist police state — ie. excessive force, abuse of power and abuse of process.

Communism (and its close relation Socialism), is a political system bankers use to control people through a bureaucracy. Communism is used to "park" entire nations during periods when their natural resources, were they allowed to be exploited at a certain period in time would increase the world's total supply unnecessarily thereby

generally lowering the demand, and as a result, would cause a fall in the price of similar resources being exploited at the same time, by the same controllers elsewhere in the world.

Capitalism is a political system that enables bankers to control people at arms-length. Here bankers and corporations use politicians and mandarins to acquire natural resources. Also, corporations armed

with unlimited finances provided by banks, buy the patents and businesses they covet. When needed, they will go as far as to bankrupt entrepreneurs who compete with them, in order to acquire assets. This banker/corporate asset accumulation is carried out on behalf of "the hidden hand" that secretly owns a controlling interest (4—8%) in each of the

Fortune 1000 companies. International bankers control their corporate assets through a complex, interwoven, system of secret fraternal or religious societies and through personally related members, they appoint to a multitude of "Boards of Directors".

Democracy is a political system that allows banker owned "Opinion Makers" to control people through their own thoughts. The most obvious

examples of these opinion makers are :

- organized religion
- public education
- the national media
- the entertainment industry
- the psychiatric industry
- the pharmaceutical industry
- the illicit drug industry
- the welfare industry
- the legal industry

Finally, Republics, such as the Soviet Union, France and the United States of America, were born out of revolutions

statement as an exhibit so that the jury could see the lie for themselves.

Neither were Dr. Lesley's memo to his boss, or his statement to the police, allowed to be entered as exhibits. These documents prove Dr. Giulivi enhanced the complaint, from what they both thought was a research call from an investigative reporter, into a threat to the blood supply. The judge's ruling on the matter was just another in a series of lies the judge told the jury. He even proclaimed that both doctors' current testimony, two years after the event, was somehow of greater value to the jury than the reports they both wrote when the two minute conversation first took place.

Yet, the judge made no comment when Doctor Lesley admitted, under Hardy's cross-examination, that he met with his boss on the matter before accepting the "spin" (Lesley was employed on a one-year contract at the time). The enhanced version was subsequently published with blaring headlines on the front page of The Ottawa Citizen. It stated categorically, without ever once using the word alleged, that "a threat to the blood supply" had occurred.

Dr. Lesley also testified that he was coached by Neil Wilson, a lawyer for the Ottawa Citizen, prior to giving his testimony at the preliminary hearing.

Later, in his address to the jury, the judge would refer to an allegation of "Abuse of power" and "Abuse of

process" made in his court by Glen Kealey, as "conspiracy theory".

Subsequently, at the courtroom door, Kealey asked the Ottawa Citizen reporter why her stories did not report the testimony that confirmed her own newspaper's lawyer had coached Dr. Lesley prior to giving his testimony — coaching that led Dr. Lesley to repeat the enhanced version prepared by Giulivi and published the next day by her employers. The Citizen reporter responded to Kealey's question by stating somewhat sheepishly, "Mr. Kealey, I am not concerned with that".

I believe her. It was the first truth I heard from the Ottawa Citizen in a very long time. Had she been concerned, or worse still, had she dared report the evidence, I believe she would have been fired on-the-spot by the Ottawa Citizen.

And because lies do not occur only by telling an untruth but also from a known omission of the truth, clearly, the Ottawa Citizen also lied in order to protect their own asses from the real possibility of a libel suit by the victim of their lies, Andrew Hardy.

But the biggest lie of all came from the mouth of the presiding political hack, the trial judge. In his direction to the jury he told them to disregard the fact that no criminal intent was proved and that no actual danger had occurred, "because these facts were irrelevant".

The judge then followed up on this big lie, by making an overt threat of his own. He read for the jury from a precedent, a prior case, where the jury in that case had decided under very similar circumstances that no crime could have been committed. Then he stated that this decision had been overturned by a higher level of political

control. The trial judge was speaking, of course, of the "judges" who sit on the courts of appeal.

These appeal court judges assure that common sense will no longer prevail in our courts of law. Justice can never result from a trial in a police state — even when the accused is being judged by a jury of his peers.

Due to the judicial manipulations now in place to limit the jury's use of their own common sense, Andrew Hardy was declared "guilty, as charged".

Still, in spite of all of this evidence and with thousands of other similar cases, some people, mostly insiders, continue to claim that we must foolishly continue to work for change from within the "JUST-US SYSTEM".

to fill the obvious gap. They were expected to be THE instrument; a new political system through which the people would gain control. World Wildlife Fund studies depopulation and control

The World Wildlife Fund (WWF, now the World Wide Fund for Nature), was founded in 1961 for one stated purpose: to raise money to drastically expand the

operations of the International Union for the Conservation of Nature (IUCN). Established in Gland, Switzerland in 1948 on a British Foreign Office-drafted constitution, the IUCN today boasts that it is the largest 'professional' international conservation organization — as of 1994 comprising 68 states, 103 governmental

agencies, and over 640 non-governmental organizations (NGO's), "many of global reach."

Under the cover of "conserving nature," the WWF-IUCN has in fact dedicated itself to 1) reduce the world's population, particularly in the developing sector, and 2) ensure that control of the world's raw materials remains in the hands of a tiny handful of largely British (or Anglo-Dutch) multinationals. These two goals, WWF-IUCN spokesmen have repeatedly stated, require a world government.

The WWF has been headed since its inception in 1961 by Prince Philip, the first head of the most important national-sector branch, the WWF-UK, who recruited Prince Bernhard of the Netherlands to be the first head of the WWF-International. After the Lockheed scandals of the mid-1970's, in which Prince Bernhard was caught taking million-dollar bribes to sell airplanes, Philip replaced Bernhard as head of WWF-I. Philip was later replaced as WWF-UK head by Princess Alexandra, first cousin to the queen.


That the Crown has directly run the WWF from the outset is lawful. The WWF-IUCN is a spin-off of two of Britain's leading imperial institutions: the Society for the Preservation of the Wild Fauna of the Empire (now the Fauna and Flora Preservation Society, FFPS, whose patron is the queen), which laid the groundwork for the game parks throughout Africa; and the Eugenics Society.

The co-founder of both the IUCN and the WWF, Sir Julian Huxley, personally embodied these two currents. He was obsessed with population control, and was called "the problem of our age." He served on the British government's Population Investigation Commission between World War I and World War II, was vice president of the Eugenics Society from 1937-44, and was its president when he founded the WWF in 1961. He also served as a vice president of "the Fauna," as its aristocratic members still fondly call it.


The ideology of both institutions, and of their WWF spawn, dates in its modern form from Sir Francis Galton, who coined the term "eugenics," and his first cousin, Charles Darwin, who in 1859 authored his infamous *Origin of the Species by Means of Natural Selection, or the Preservation of Favoured Races in the Struggle for Life*. Galton aimed to propagate the pseudo-scientific humbug of

When the anti-creator decided to hire a lawyer, to handle the most delicate of tasks, he dared not take a chance on those individuals whom his mind-control system had mass-programmed, within his "sponsored" institutions of higher learning. These institutions are places we call universities. After all, in his wisdom, the "degree" of brain-washing he knew they provide is somewhat less than was needed to properly program an "angel". Much as before, having learned from the plan created to confuse people with Gods of organized religions (not to be mistaken for SPIRITUALITY), the current High Priest of Egypt's ancient ISIS cult chose Maurice Strong at birth. He would deceive many with his "Cloak of Green".

Strong was born into the family of a man who "just happened" to work for the Canadian Pacific Railroad (CPR). Later, he was sponsored, guided and privileged throughout his years of basic public education. He graduated at the age of 14, having skipped four grades. *This basic education coincided with the 1930's depression years, leading up to the start of World War II.* Both events were orchestrated — the end result of a banker induced Wall Street stock market crash, in 1929. The "crash" promoted American central banking designed to indebted the peoples of Canada and the United States. Income taxes, to pay this debt, were being justified as a means to support the war in Europe and Japan. In fact, what occurred was a "cost-free urban renewal" prior to the sale / purchase of these nations by the current Money-changers.

Maurice Strong's first on-the-job training occurred when he left Oak Lake, Manitoba (near Brandon) to train in the "free-traders" merchant marine. Later, he joined the Hudson Bay Company. His assignment was to infiltrate native communities in the high arctic. This allowed him to identify Inuit leaders who could be bought or blackmailed. They would be paid to work against their own people's best interest.

The Hudson Bay Company, like its sister companies, the East India Company of India and Kuhn-Loeb of the United States of America, was created to steal resources from the Natives who first occupied the land. Kuhn-Loeb is now known by the corporate name it acquired in 1985, American Express. These three companies are wholly owned properties of the British banking oligarchy. Bankers, using the weapons of inflation, deflation, taxation and bankruptcy have acquired these lands from the immigrants. They are controlled through the agri-business Fortune 1000 companies they manage.

The East India Company waged OPIUM wars against China and was involved with the slave trade of Africans brought to America. Two hundred million Blacks died

in this the world's deadliest holocaust. By comparison Native North American Indians lost one hundred and fifty million people over a 500 year period, as Europeans were sponsored by bankers to immigrate and steal Native land. The Chinese and Soviets lost 60 and 50 million respectively, during their Communist revolutions. As far as I know, not a single national monuments remembering these holocausts was erected. Seldom does the media even speak of them.


By the young age of 25 Maurice Strong moved up the corporate ladder at break-neck speed. First, he was appointed President of Dome Petroleum. Then, at the age of 31, he became President and CEO of Power Corporation where he came in contact with his protege, Paul Martin Jr., Canada's current Minister of Finance. Next, two successive Canadian Liberal administrations led by Prime Minister Pierre Elliot Trudeau made him Head of the Canadian International Development Agency (CIDA) and then sent him into Alberta's oil patch to direct the newly created national oil company, Petro-Canada.

At CIDA Strong showed public servants how to launder Canadian tax dollars through phoney Canadian based "environment charities" who would then pass it on to their counterparts in third world countries. With this money now in the hands of foreign "charities" these, in turn, could legally bribe corrupt politicians and judges in their own countries. Of course, the politicians they sponsored would, in return, always support the internationalist bankers' free-trade corporate agenda.

Maurice Strong, having learned to disguise his true role as a bought-and-paid-for employee of the European bankers' cartels, hid behind an illusionary public image, in the cloak of green worn by "environmentalist". A Rockefeller controlled Trojan Horse, the United Nations in New York City, appointed Strong Chairman of the EARTH SUMMIT conference held in Rio de Janeiro, Brazil, in 1992. The conference guaranteed him worldwide recognition. From this position he was able to better defend the international corporate agenda.

Cartels prosper when they can limit the supply of certain goods such as oil, gold, diamonds, lumber and money. If the supply of these goods exceeds the demand then prices stabilize, or worse, decline. Therefore, it sometimes becomes necessary to limit the exploitation of these resources in one part of the world while continuing to exploit the same resource elsewhere.

An example of this practise can be easily tracked in Washington State. The largest paper manufacturer also funds the environmentalist movements who try to prevent logging. When the price of paper stabilizes at a certain level, "tree huggers" are sent into the bush to



stop the logging. Once they are gone, environmentalists are blamed for the price of paper and prices go up. As consumers pay the price, the "greens" lose their funding and resumes its former frantic pace.

Strong purchased the Baca Grande ranch in 1978. He joined with others based in the property covering 142,725 acres, the largest land purchase. One factor he considered in making this deal was that \$30 million had been spent, by previous owners, on the property. Another much more important factor was that the land sat above an underground reservoir of 250 Lake Okanagans, in British Columbia. The land was located at the centre of which his boss, Lord Rothschild, was the world's first "food cartel". At \$5,000 an acre, the fresh water beneath would someday be worth billions.

The problem was how to keep the

Baca Grande ranch in Colorado is the latest in a series of ranches based in Chicago to buy the 2,725 acres, as part of a much larger plan. One factor he considered prior to buying the land was that \$30 million had already been spent on the ranch, constructing roads on the land. The much more important secret, was that an underground aquifer the size of Lake Ontario, in British Columbia. As well, the ranch is located in the centre of vast farm land on the Baca Grande, which is owned by the Rothschild, intends to create the world's largest farm. At \$5,000 per acre foot, the land could someday be worth trillions of dollars.


such time as he could arrange the diversion of Canadian fresh water to refill the aquifer and replenish the water he was about to sell. Finally, the answer would come to him through his second wife, the Danish born gift he received from his European bosses. Introduced to her in 1970, at a party in New York city, they married shortly thereafter.

Unbeknown to most of us mortals, Denmark plays a very important role in the world of bankers. Because Denmark claims to own Greenland, a large block of ice on a very large island strategically located between America and Europe, it has become the logical place to relocate numerous precious inventories that enable the world cartels to exist; inventories that were formerly stored in Switzerland. Since easy access to Greenland is completely out-of-the-question to most citizens of the world, it is as safe a place as they can find. From under the ice, bankers intend to ride out the nuclear fallout they will create when they eventually launch the next, final world war, Armageddon. Greenland will be the international bankers equivalent to Noah's ark.

When they finally emerge, they expect the world to be a very different place, populated by at least two billion less inhabitants. Two more billion people are expected to die with the imposition of a centrally managed food distribution plan, based on the limited production quotas enforced by the future North American food cartel. It will deny food to those people that banker's will designate "useless eaters".

Hanne Strong claims to have conceived her plan to hide the true purpose of the ranch when she was visited by an old man named Glen Anderson. He was Native, originating from the area. He spoke to her at length about SPIRITUALITY (not to be confused with religion). Yet, she claims that following Anderson's visit, alone, she went up the Blood of Christ mountains, and like Moses, spoke with GOD about religion (which is not to be confused with SPIRITUALITY). She says God instructed her to convince her husband Maurice to use the ranch to launch a New Age, New World Order religion (not to be mistaken for SPIRITUALITY).

With these instructions she obtained directly from God, it was all Hanne Strong needed to convince her "angel" husband to get on with it. Baca Grande, apparently began its new mission in life with both the personal and financial endorsement of the multi-trillion dollar Rothschild banking empire of Europe (the anti-creator). Once kick-started as a centre of world religion (not to be mistaken for SPIRITUALITY) other Rothschild underlings such as the Rockefellers soon joined with Maurice's original Canadian sponsor, former Prime Minister Pierre Elliot Trudeau and other political leaders to vouch for this New Age religion (not to be confused



with SPIRITUALITY). The Strong's then hired the Hollywood ding-bat Shirley MacLean, to mass-market their "revelation" to the rest of us.

Tourist attractions, such as Hell's Gate in B.C. and public National Parks have long served the elite who want to hide the true purpose for which they intend to use this valuable real estate in the future. The creation of national parks by governments enables bankers — now that all income taxes collected from the public are owed to them — to grab these equity properties as additional security on the nation's debt. Once a park is established it allows government to evict the residents and build roads at public expense. Quietly behind the scene, "sustainable" development is authorized and the bankers' friends move in to build vast hotels and exploit the parks natural resources.

The Baca Grande Ranch is located in southern Colorado, where Highway 17 crosses the Rio Grande river near Alamosa, in the San Luis Valley. Crestone is the closest town. It was born during the Gold Rush of 1880. Gold rushes are a favorite trick used by bankers when they want to open up an area for development. Greed can always be counted upon to attract a sufficient number of prospectors and developers. Once they see a few gold nuggets thousands more will flock to the area. With the small amount of gold these people usually find, one may suspect that prospectors were often fooled into participating in gold rushes at the sight of bannock, the golden bread which is often consumed in Native communities. In any event bannock is, at least in my submission, a better reward for the effort than is gold.

Christians, Moslems, Hindus, Buddhist, Native Indian Shamen, Hollywood actors, world famous politicians, bankers think-tanks and religious societies of all kinds were funded to move to, or at least make an appearance at Hanne Strong's husband's ranch. BEHIND GUSTAFSON LAKE

The man is gentle, direct and plain-spoken, not at all what one would expect of a person some circles think of him.

Glen Kealey is a former Ottawa-Hull area property developer who stood to make millions on a high-tech development but dropped it all, on principle, when a Tory federal cabinet member said he'd support the project only with the payment of what Kealey calls a five per cent kickback.

It was the beginning of a personal crusade Kealey has been waging against what he believes is systematic corruption tied to international banking cartels intent on robbing Canada of its independence, minerals, forest and water resources.

And he believes that threat is intimately tied into what happened last summer at the Gustafson Lake standoff.

When reporters questioned the leaders of the armed camp west of 100 Mile last August, their spokesman, who called himself Wolverine (Jones William Ignace), cited the right to hold Sundance ceremonies on unceded Shuswap lands — and concerns about a New World Order.

The theory was authored by Kealey, who met Ignace and others on a western speaking tour two years ago.

Now Kealey intends to spend several months on the Lower Mainland assisting Ignace with his defence on charges stemming from the standoff.

"We've taken the stand that the traditional natives need traditional Canadian support," Kealey said last week.

He compared their disdain for elected tribal councils and Assembly of First Nations Grand Chief Ovide Mercredi to political differences within mainstream society.

"Many people think an Indian is an Indian," he said, but their views can be as different as any segment of society.

And Kealey's views are a little different.

"This particular standoff had a much broader scope," he explained. "It's tied through circumstantial evidence to a much larger puzzle."


It came to his attention because of "the magnitude of the response" by government and the police they control." This had a bigger purpose than just moving 18 natives."

In a nutshell, Kealey came to the conclusion that the Gustafson Lake area was being "parked" on a fee-simple basis with American rancher Lyle James (who came from Montana) so that the lake, 100 Mile House and Williams Lake could later be joined with other such "parked" properties.

These would assist in loading bulk water resources from the Fraser River to be shipped eastward over the Yellowhead Pass.

There it would join similarly diverted waters from James Bay in a Grand Canal to supply the arid North American heartland with irrigation for an international food cartel tied to the European Rothschild banking family.

All of this would be half funded by the \$100 billion gleaned from those five per cent kickback he tried to expose earlier.

"Voicing all of this led to the national media increasing their attacks on me," said Kealey, who mounted a 1,000-day protest campaign on Parliament Hill over his earlier corruption charges against the Mulroney regime.


"What happened to natives is happening to the middle class," he said. And that is why he must continue to help the man called Wolverine.

To assist him in his need to divert fresh water from Canada's north, Strong temporarily moved to Ontario. He was hired by Bob Rae, the socialist NDP Premier of the province. As Chairman of Ontario Hydro he was in perfect position to add pressure on Ontarians to dam more rivers and prepare for the construction of former Prime Minister Brian Mulroney's Grand Canal water diversion project.

Although Strong knows all the facts about nuclear power and how safe and inexpensive these power plants are — no nuclear plant, even when one includes Chernobyl and Three Mile Island, has ever leaked due to construction failure by only because of human "error" — he proceeded to shut Ontario's plant down. This would eventually cause shortages which would be relieved with the construction of more dams on rivers.

Because "free-flowing water" is not a "GOOD" under existing free trade laws, it cannot be exported without government approved permits. Once water is held behind a dam however, it becomes "self-contained water", and as such, is considered private property by the World Trade Organization, the GATT and NAFTA. When this happens governments no longer have a say about the export of fresh water. This is the condition Strong wanted to create while at Ontario Hydro. He succeeded.

As well, as Chairman of Ontario Hydro in 1994, he tried to spend their money, (\$10 million) to purchase a part of Costa Rican national debt, in an international shell game, a debt for nature swap. This occurred at the same time he was cutting 10,000 Canadian jobs at Hydro.

A spokesperson for Hydro said he saw no connection with the fact Strong also owned land in Costa Rica. He said the purchase was being considered on environmental grounds — saving a large forest would offset the pollution causes by coal burning power plants.

If that is the case the spokesperson was asked why Strong and Brian Mulroney were cooperating with Power Corporation's plan to build dozens of coal-burning plants in China. He had no further comment.


Recently, Maurice Strong is being "pressured" to replace Boutros Boutros-Ghali as Secretary-General of the United Nations.

There is no longer any doubt that the evil anti-creator has positioned his ANGELS well, in preparation for his final assault on humanity as we know it.



Dear Glen,

I regret that due to a previous arrangement I had to leave the January 28 meeting in Peterborough immediately after your informative speech and didn't have an opportunity to speak with you.

As I have mentioned to John Welham, my experiences in dealing with the Federal Government and members of the unbridled Federal Bureaucracy are (except for scale) a close parallel to yours.

I agreed to run The National Federation of Insulation Contractors Association (NIECCA) in 1983, for 6 months to develop a working federation to provide collective representation to the small business contractors against the financial atrocities inflicted on the Industry that wiped out 80% of the pre CHIP contractors from coast to coast and every contractor in Peterborough including those established 30 years prior to the corrupt vote buying CHIP program.

Ten days after I was elected president of NIECCA, CHIP administrator Richard McKenzie made a special trip to Toronto, took me out to dinner and then asked how much I lost when the Government shut down the Industry. When I said I lost my business plus my entire life savings, retirement pension funds, life insurance and was on the verge of personal bankruptcy about to lose my house and farm that was previously paid for but was then heavily mortgaged at 21% interest. McKenzie encouraged me to stay on as manager and work in cooperation with him. The Government would fund the new fledgling Federation and I could be the manager with a salary of \$45,000 per year and he could give me side contracts for another \$30,000 for a total of \$75,000. He said "That's the way it's done here in Ottawa" and referred to a lady manager of another association who had a similar arrangement.

I recognized it as a direct conflict of interest and an out and out bribe and declined. He later tried 2 other schemes to get me hooked but in each instance I recognized the situations as fraud or borderline and declined to sell my integrity to the young hoodlums of Marc Lalonde's Energy Mines and Resources. Soon they realized I could not be bought, they stalled and refused to even correspond with me. Over 14 letters from myself and other provincial representatives were never answered until after 7 months I resigned and then the Government took over NIECCA, placed their selected manager in charge, changed the direction of the organization from a lobby group representing contractors, to an agency, running seminars for the Federal Government.

All of the Provincial Contractor Associations and all of the insulation contractor members opted out and the Government ran a phoney puppet corporate front until the end of the CHIP program that killed off the last bastion of hope for destitute contractors as depicted by the CBC-5th Estate exposé of September 27, 1983.

The method of control was by way of a Government lead contract for \$2,000,000 granted to a former president of a company associated with a former Liberal Government Cabinet Minister. Through this Government agent, and a manager recruited by the hoodlums of EMR, funds were channelled to NIECCA and the directors were kept in line by the perks of meetings held in Vancouver all expenses paid.

It is amazing just how little it takes to buy the integrity of so many people.

Comments on the January 28 Peterborough meeting.

The idea of 100,000 people on Parliament Hill is interesting and while no one can say for certain what it might accomplish, it certainly would draw attention to any well prepared protest and at this point in time an action worthy of support. At first it seems that considering the extreme apathy of people in T.R.O.C., assembling 1,000 people would be difficult let alone 100,000.

However, when we take a closer look at the numbers by district, the magnitude of the job broken down into individual ridings makes it more believable and as you no doubt know, people must believe they can achieve before they will go all out.

With a population of approximately 60,000 in Peterborough and 17,000 in Lindsay making a combined total of 77,000 or approximately 1/4 of 1% of the 30,000,000 population of Canada, it would seem Peterborough would need only recruit approximately 213 people to meet its commitment and the City of Lindsay need only provide 37 people. The total for these 2 areas being 250 as a quarter of 1% of the 100,000 required which is the % of the population of Canada represented in Peterborough and Lindsay. With each area striving for more than its minimum requirement in order that stronger areas cover for weaker areas, it seems your goal of 100,000 is believable and I think you will find people more receptive if you introduce their role in this manner, showing the smaller figure they need to recruit from their riding based on its % of the population.

I congratulate you for your efforts and wish you all the success you so richly deserve.

This office has carefully reviewed tapes of the CBC program Sunday Morning, aired on the 14th of July 1996. It is our opinion and that of our Legal Branch, that there are no grounds for preparing a Crown Counsel Report as no criminal offence has been committed. There is nothing in the broadcast that falls within the type of

Furthermore, contrary to a mainstream media story, no proof has been entered as evidence to conform that a helicopter was ever hit. Nor can one hear shots or other loud noises, from fifteen hundred feet AGL (above ground level), when one is wearing a communications helmet, and especially, while sitting directly under the noisy transmission of a Bell helicopter.
