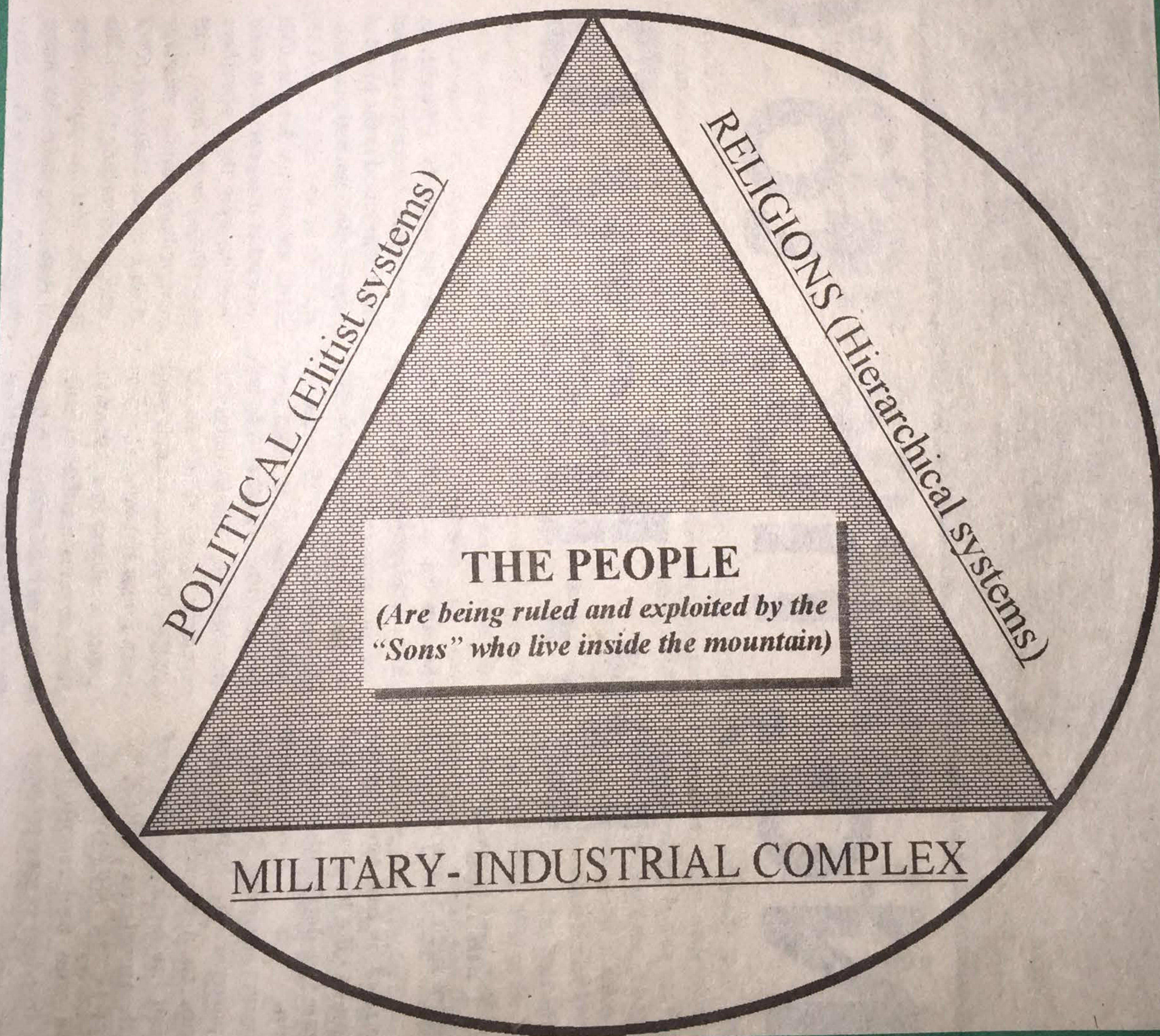

JUDGE THREATENS JURY WITH LAWSUIT

The Gustafson Lake standoff trial jury had seen and heard just about all they could take in the way of lies by the police as well as the manipulation of the evidence that was allowed to be entered by the trial judge and crown prosecutor.

After listening politely to the evidence for 10 months in a Surrey BC courtroom the jury foreman finally rose to speak. He informed the court that he had been directed, by all the members of the jury, to make a formal statement. For just a moment the trial Judge, Bruce Josephson, thought he might lose control over the carefully selected words that he had allowed to be entered on the trial record, during the entire 10 months of the trial.

Then, the Judge's 20 years of training kicked in. After all, how could he let the Jury

foreman destroy the illusion of justice that he had so carefully crafted during the trial; by withholding crucial evidence and by helping the police to manufacture testimony? On at least one occasion he even told an officer how to testify.

In a written decision that the judge had made, about which RCMP "Training Videos" could be played for the jury, the Judge had suggested to Sgt. Peter Montague that he could defend the words caught on video tape as "having been stated in jest".

Sgt. Montague was seen by the jury attending an RCMP command meeting during the Gustafson Lake Standoff where he openly admitted, on video tape, that during the break he had prepared a "smear and disinformation campaign" against the Native defenders, and also, that "smear campaigns are a specialty of the RCMP".

Judge Josephson responded to the Jury Foreman that "although it is a legal right for a Jury to make a statement, such a practice was highly unusual." The Judge added that "such a statement would open up the possibility of a libel suit being filed against the members of the jury".

As a result of the judge's response the Jury decided to deliberate further.

When they returned many members of the jury, including the foreman, were in tears. The Judge's warning had been sufficient to destroy the jury's unanimous desire to speak out about the injustices they had witnessed during the trial.

By his lie, about the possibility of a lawsuit being launched against them if they spoke the truth that was in their hearts, the trial judge had relegated the jury merely to the role of a rubber stamp for his original instructions.

With but one kick-at-the-can left in them, the jury declared the accused to be "not guilty of the most serious charges laid against them", declaring them "guilty" only on the least serious charges. The Judge in turn, not wanting to be denied his chance to earn his political puppeteers respect, went on as if nothing had occurred, and later, proceeded to sentence the Native accused as if they had, in fact, been found guilty of the most serious charges.

William Jones Ignace was sentenced to eight years in a penitentiary for shooting six tires on an armoured personnel carrier (APC). Police in the APC had shot at least thirty nine bullets at two unarmed youngsters they had forced to take refuge in the water of Gustafson Lake. This happened after the RCMP and Canadian military had, under pretext of negotiations, blown up the defenders truck with a land mine.

governments, as well as many fully coordinated military-industrial complexes world-wide. These so-called "public" institutions always conspire, either separately or together, in order to continue the obviously *sinful* accumulation. 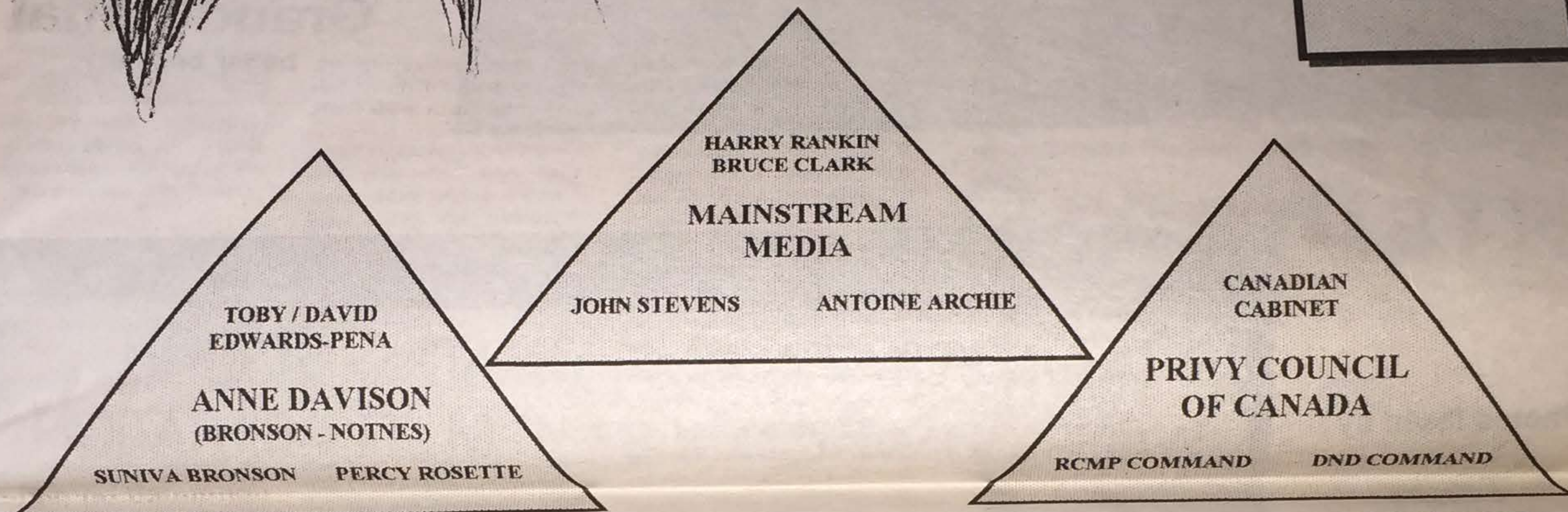

The following is the text of a third party Fax I sent to the BC media. It is addressed to Aaron Dinwoodie, Chair and R.A.C. representative for the Regional District of Central Okanagan, as a result of a meeting I attended August 13, 1997, in Westbank BC. He is the local "sheep-herder" for the political big wigs of Ottawa and Victoria.

Sir:

I attended your meeting at the Lion's community hall in Westbank last night.

After observing and analyzing the type of questions raised by the audience I concluded that most of your audience consisted of the 87% of our local community that lives in fear and identifies with their captors. This, one expects to find only when people were lied to from birth — in this case, about the real history of Canada, our country. Unfortunately you also, knowingly or unknowingly, added to the disinformation that was being propagated

about our past.

Mr. Dinwoodie I suggest that you review and revise the historical and legal time line — it begins on page 2 and continues on page 3 of your document titled *Westbank Treaty Negotiations (Westbank Local Government Treaty Advisory Committee)*, published and dated July 1997 — because, in part, it is not factual.

Some examples of the errors and omissions, were they corrected or included would help clarify the historical perspective and bring back a sense of reality to the important current debate, are as follows:

1763 — With a revolution against the Crown brewing in the American colony to the south, Queen Anne needed all the allies she could muster, if she was going to save any part of the North American continent for England. This is why she agreed to protect native land. The exercise was totally self-serving on the part of her controllers. Without the help that England received from the aboriginals there would have been no Canada.

1850 — This section in your document makes no sense at all. It states, "After Douglas retired, the policy to acquire lands was reversed and aboriginal people lost their right to acquire CROWN land". Why, Mr. Dinwoodie, would the native people even contemplate buying their land back from Joseph Trutch — the Government protected land thief? Surely, as a moral upstanding law maker, you

are aware that land theft is a crime in our society.

Or, is it that you believe that there exists a "Statute of Limitations" on land theft in Canada. To the contrary sir, when BC first asked to be admitted into Canada it was denied the privilege, until it promised to reverse the land theft from the Indians (see the "Duty of Disallowance"). However, because BC was a haven for organized criminal politicians at the time, it responded to the condition set by the Government of Canada in the only way crooked politicians know how. The corrupt BC leaders bribed an even more corrupt Sir John A. MacDonald, the first Prime Minister of Canada. As a result, instead of enforcing the "Duty of Disallowance", MacDonald took the bribe and then he introduced the Indian Act. 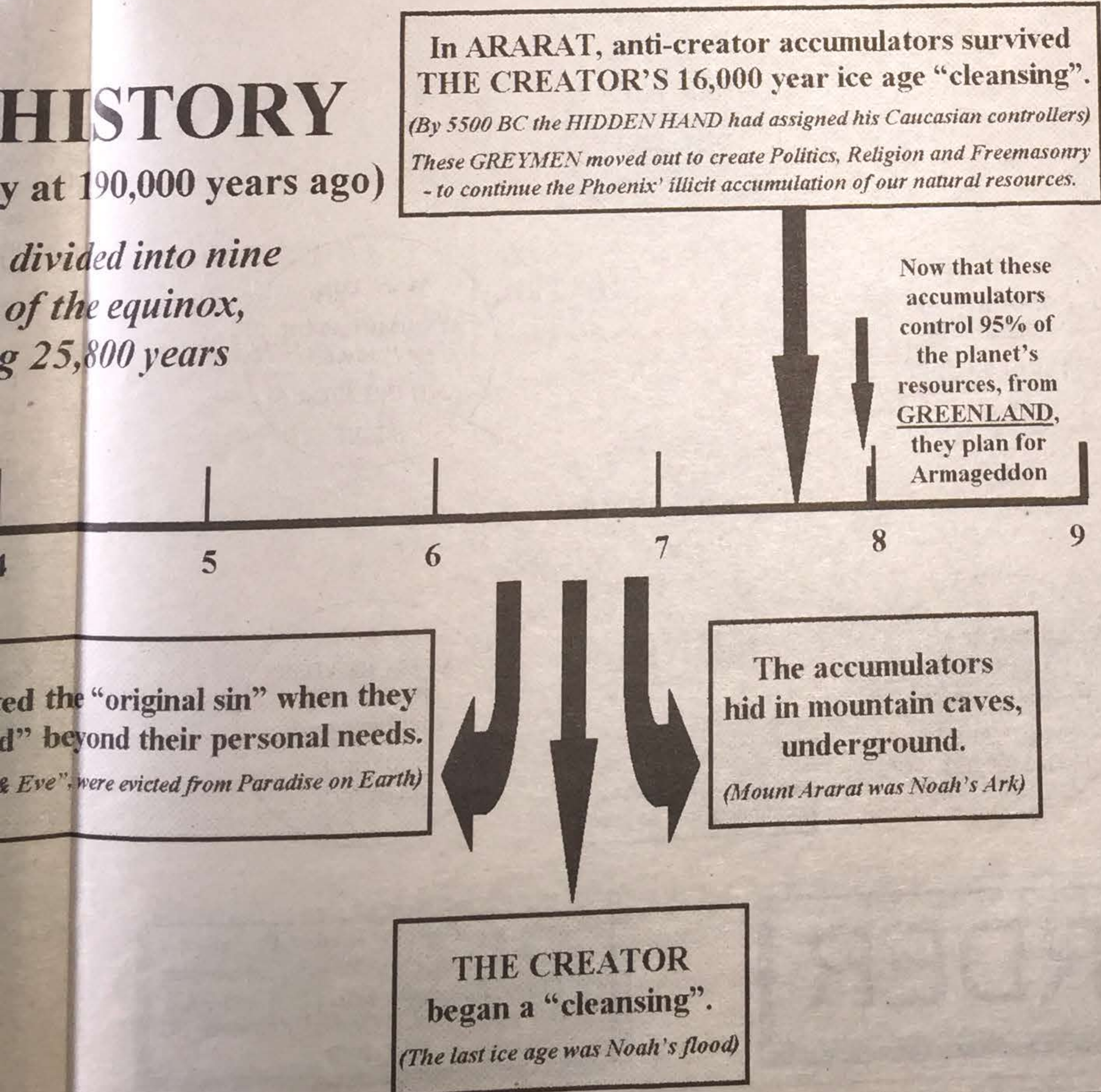

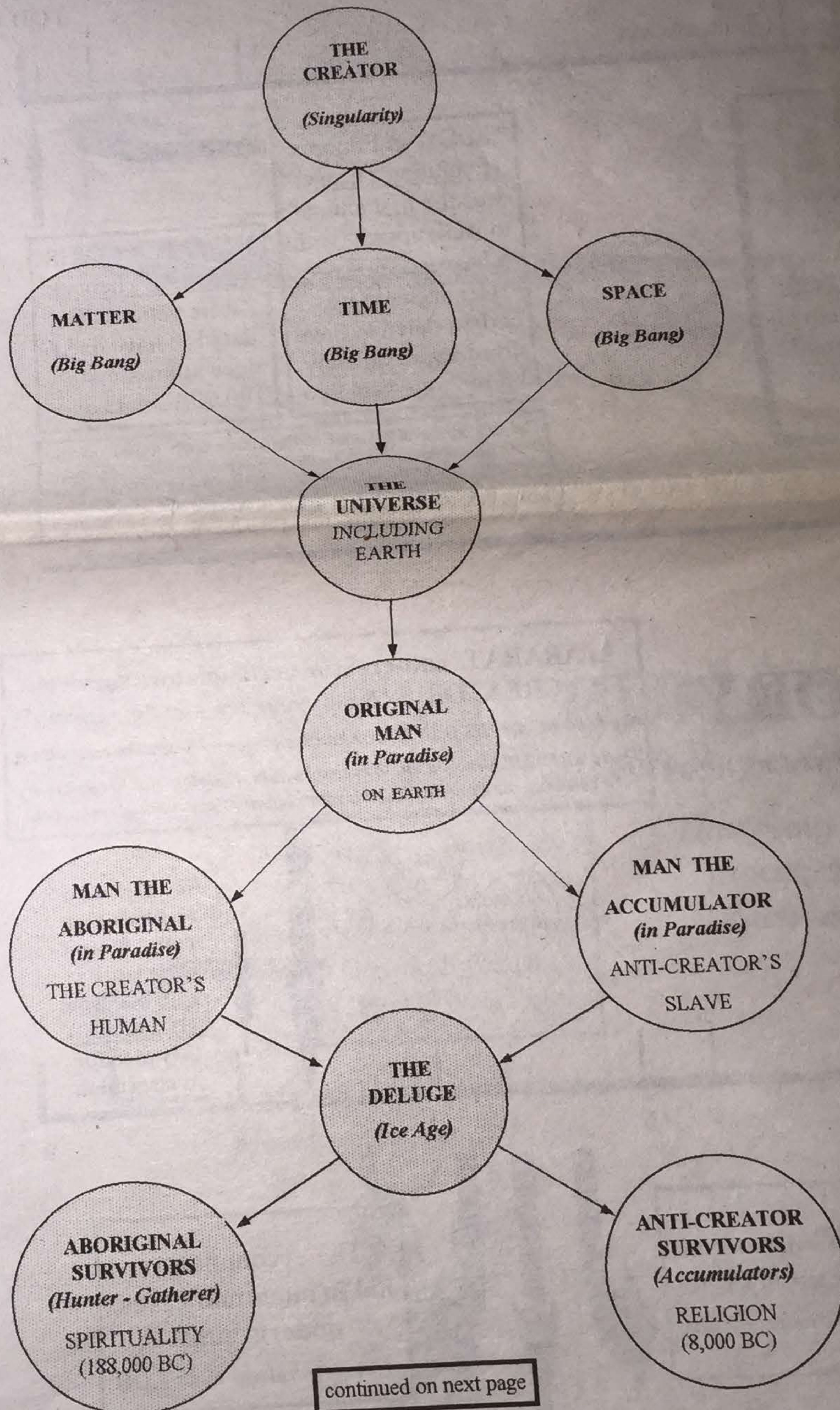

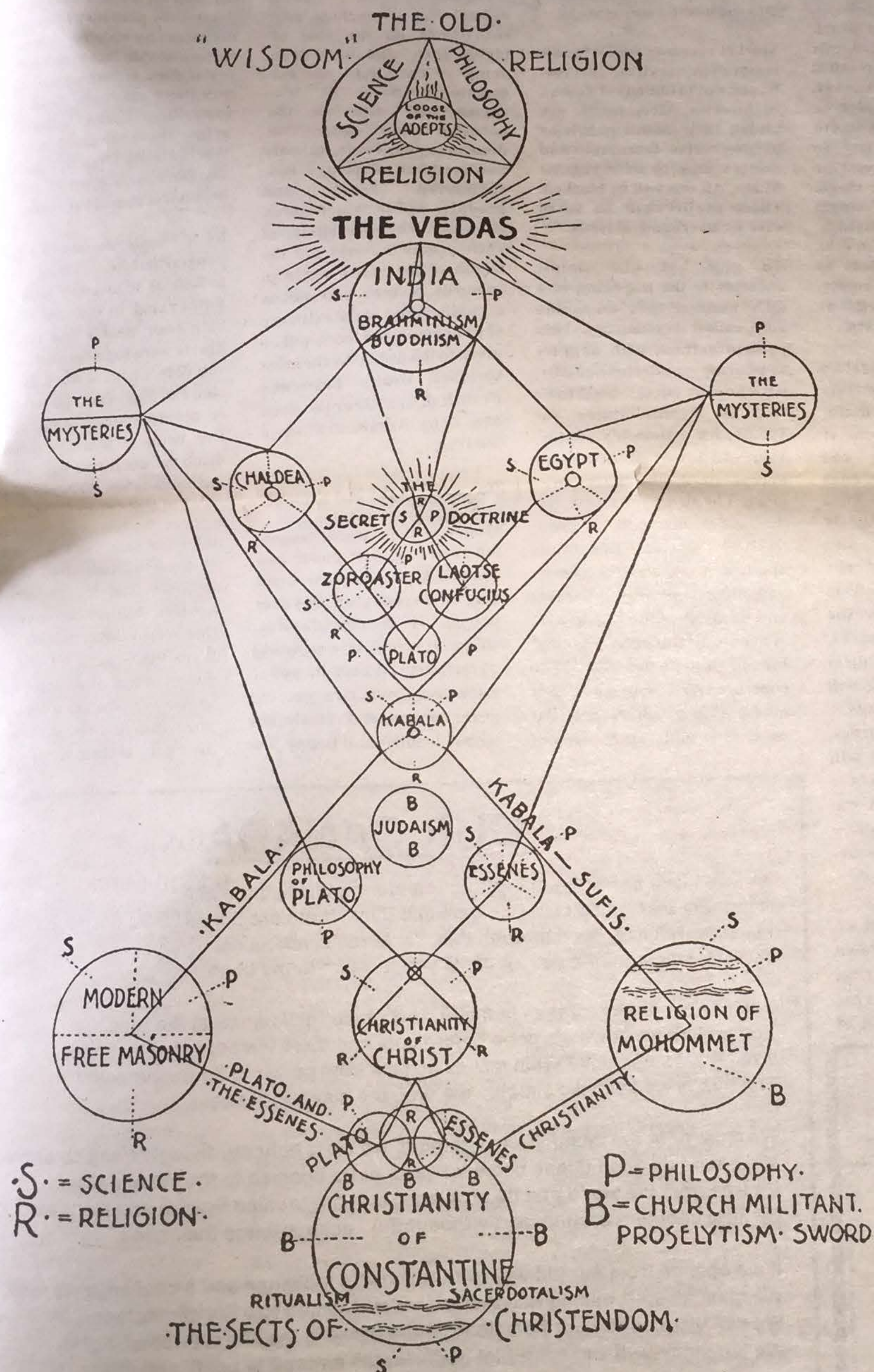

A medical doctor speaks out

The pounding of hoofs is becoming louder and louder as we hear the four horsemen of the apocalypse — war, famine, pestilence and disease — riding in from the distance. Currently the fourth horse — disease is being given the lead. His name is Codex Alimentarius.

"Codex", in the medical dictionary means an authorized medicinal formulary — a pharmacopeia — a codification of medical legislation. "Alimentarius" means applied nutrients — supplements, vitamins, protein extracts and herbs. By the stroke of a pen all these products that modify and benefit the processes in our bodies that create health — in a word, that "cure", have been twisted to mean "drugs".

We all know drugs are hazards to health. They can be dangerous. They must be controlled. A system of control must be established. It is for the good of the people. (Somehow this song sounds familiar). How? Give each health restoring substance a Drug Identification Number — a DIN. But a DIN will mean anybody in need of any form of healing must apply to medical doctors for a prescription for any such product. They will not be able to obtain any health restoration remedies from herbalists, health stores, N.D.'s or other health care professionals.

Only medical doctors are allowed to prescribe drugs. Medical doctors are trained in health care. But they have no

training that gives them the ability to prescribe health restoring supplements or remedies. There is no provision for the judicious use of anything in medical schools, medical literature and practices other than the chemicals that the pharmaceutical companies create and market. They have no knowledge or experience in the use of health restoring products. They do not know how to prescribe them. Nor is there a single drug that can cure a single person of a single disease. Drugs and chemicals are as incompatible and useless as means of repairing the structure and functions of cells, as Ford parts are to Cadillacs.

About 80% of the world's population depend and rely upon herbs for the maintenance and restoration of their health. In this one consideration alone Codex Alimentarius threatens 80% of the world's population. By one clever, cunning and insidious ploy, none of the things that can contribute to health or that can help cure the well over 2,500 diseases, categorized by the medical profession as 'incurable', will be made available to those sorely in need and in distress. No dietary supplements will be allowed to be sold for dietetic, preventative or therapeutic use. Is this not a strategy for dictatorial takeover?

This one legal document — Codex — will close down health stores and bankrupt both supplement and herbal companies. It will put out of

practice the thousands of practitioners offering health restoring services — the herbalists, the Naturopathic Physicians, the nutritionists and the health counselors.

Market revenues for all health restoration services, currently, amount to billions of dollars in America. More people are taking their health problems to alternative therapists and doctors than to their regular M.D.s. All this will be blocked. These profits will be taken over by the chemical lords.

To give but one simple example is the imposing of a DIN number onto an amino acid called Tryptophane. This protein extract, with abilities to provide wonderful benefits, with no side effects, used to be sold in health stores for \$15.00, for a month's supply. You can't buy it anywhere except in a pharmacy anymore. The drug store cost, for the same amount, is now \$120.00. The same fate awaits about a hundred other herbs and almost all your vitamins and minerals. One has to ask: Where is all this money going? What is it to be used for? Who controls it? Any in-depth investigation will reveal that most of it ends up in the big

banks and in the pockets of the powers that are working towards a take-over of the world.

Incidentally, the Codex decrees do not include any restrictions on the sale of highly toxic and hazardous drugs or chemicals, nor the genetic products of bio-engineering, with all the potential they offer for denaturing our foods, animals and even our offsprings. Bio-engineered foods and products are serious hazards to health. The side effects of such products could put the health of the entire world in jeopardy. No laws, precautions or notifications of the existence of bio-engineered foods will be given to the public by the same so-called Health Protection Branch of Canada or the Food and Drug Administration of the USA.

But money is the real name of this ingenious chess game. Money is their main weapon for enforcing their power and control. Money is control, not only of markets, but also over people. What exactly is DHEA? According to Dr. Rona, "Dehydroepiandrosterone" was once thought to be a precursor to other hormones such as testosterone, progesterone, cortisone and estrogen, and had no specific role of its own for the body. Recent studies done on animals and humans over the past decade or so, however, have shown this not to be true. DHEA can be found in almost any organ in the body and is the most abundant steroid

hormone secreted by the human adrenal gland.

DHEA blood levels decline progressively with age, a phenomenon that does not occur with any other adrenal steroid. Epidemiological studies show that higher DHEA levels are associated with increased longevity, less cancer and less heart disease, thus suggesting that at least some aging manifestations may be caused by DHEA deficiency. DHEA may prevent obesity, diabetes, cancers of the breast, colon and liver, osteoporosis and Alzheimer's disease and the list goes on.

In Canada, there are thousands of users of DHEA. These people have now been turned into instant criminals should they attempt to order DHEA from the United States, where it remains (so far) a legal over-the-counter product. The penalties for trafficking and possession for the purposes of trafficking in Canada are severe. The length of imprisonment ranges from a term not exceeding (18) months, on summary conviction, to a term not exceeding (10) years on conviction by indictment (Sec. 39-3 Criminal Code of Canada).

Just who is behind this nefarious meddling with health choice in Canada? Turns out it is the Health "Protection" Branch (H.P.B.) of Health and Welfare Canada, a federal bureaucracy which has garnered quite a reputation for its K.G.B. style tactics and which probably took lessons from the equally nefarious F.D.A. Both are old hands at bullying threatening, shutting people down and generally acting like common thugs! The H.P.B. has classified DHEA as an anabolic steroid which in their narrow outlook makes it a controlled substance or drug. Yet, prior

to December 19, 1996, DHEA was just another natural hormone found in the blood of any healthy, normal person.

It is about time for the Cali and other drug cartels to start looking over their shoulders as they now have stiff competition for the moniker "King of the drug Lords" if all goes according to plan, the H.P.B., F.D.A. and other alphabet agencies in many countries will have completely banned the use of most if not all nutritional supplements before the year 2,000.

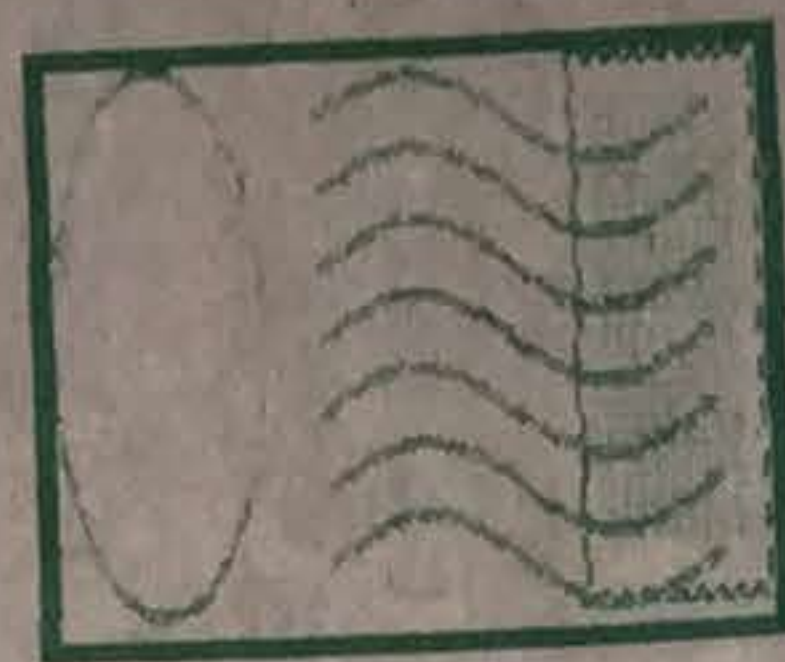
