Canada's heroes come under attack PRIVY COUNCIL RUNNING SCARED

Shelley Ann CLARK

One could not imagine two people more different in their origins than are William Jones Ignace and Shelley Ann Clark.

Jonesy, as he is known to his friends, is a 65 year old native born in the Cariboo area of British Columbia. For most of his life he has had to scratch the ground for a living, first as a logger and then as a farmer.

Shelley Ann, 53, on the other hand was born in the lap of luxury in a swanky section of Rockcliffe Park, in Ottawa. Rockcliffe Park is the very best Ottawa neighbourhood. It is chosen by most ambassadors assigned to Canada.

Like most natives who grow up in Canada Jonesy had to handle his daily chores pretty much by himself.

Shelley Ann's time however was not so burdened. You see, she had Oscar as her personal butler from birth and until she turned 28. Oscar would lay out her clothes every morning before making her breakfast that always included freshly squeezed orange juice.

Since 1875 the only public education Canada's original people received was worse than if there was none at all. Residential schools in B.C. were nothing less than government-sanctioned genocide — direct attacks on native peoples spirituality and culture. Jonesy survived in school just long enough to learn to read and write.

Shelley Ann went to the best private schools and colleges money can buy. Oscar would help her to put on her boots as she left for school. He was also there to help her change when she returned. Oscar always made lunch and prepared her snacks.

Again, as with most traditional natives, Jonesy did not have much to look forward to in life, except to earn a meager living for himself and his family; scraping by in the bush, doing the most dangerous jobs most whites and Asians would not even consider. Alcohol made things easier in the early days.

Shelley Ann never had to look for a job. It was there as soon as she graduated from private business college. She was only sixteen when she joined the then Canadian Department of External Affairs, before it became known as Foreign Affairs Canada.

Shelley Ann was awfully young to be wandering the halls of the United Nations in New York. But in her case that was the life she was born into and one-must-do-what-one-must-do. Inexpensive, tax-free alcohol was everywhere at the UN, however, the diminutive 5'3" girl from Ottawa quickly learned that she could only handle one glass of wine, and that, only at the end of her day.

When Jonesy's first wife was killed, he remarried, this time to Flo Sampson, his current wife. His life took on a new direction. Flo was also a Shuswap. She taught native

language courses on the Adam's Lake reserve. The Elder, Jonesy Ignace, became a seed farmer. He grew open-pollinated seeds for his people and also became well-known as a spokesperson for native rights. Among his people he is known affectionately by his Native name, the Wolverine.

When Oscar died, Shelley Ann had no alternative but to marry. Her first husband was an insider with links to the British oligarchy. Money was never a problem and maids were hired to mind the house, which was complete with an indoor swimming pool. Her two boys, Stephen and David, were the joys of her life and she took them everywhere.

Shelley Ann's life was also destined to take a sudden turn. In 1986-88 she was assigned to the Canada-USA Free Trade Negotiations. While cleaning out her boss' safe one day she came across evidence of High Treason by our former Conservative Prime Minister, Brian Mulroney.

Shelley Ann Clark had just discovered what Jones Ignace, had known for years. Canada was being run by puppets dancing to the tune of a foreign power — a hidden hand.

What in the world could ever conspire to bring these two so different individuals together? It can all be boiled down to one word INTEGRITY. You see, my fellow Canadians, integrity is not only a gift, it's a burden.

When one is burdened with incontrovertible evidence of a preventable calamity that will affect the lives of generations still unborn, these human beings afflicted with integrity do everything in their power to warn their family, neighbours, friends and countrymen of the danger. They will do so even knowing that the "system" will come down hard on them.

None-the-less, they take a risk that the beneficiaries of their courage will not let them stand alone. While whistle-blowers are prepared to stand openly and shout FREEDOM they also have the right to expect that others will at least whisper freedom from behind.

Today the Wolverine is locked up in a jail cell at Matsqui Penitentiary in BC. At Gustafson Lake Jonesy took a stand for his family, friends, neighbours and countrymen. He shot at the tires of an APC, an armoured personnel carrier that was shooting at unarmed kids in the lake and who then tried to kill him. The jury said he was innocent of attempted murder but the judge sentenced him to eight years anyway. Now Jonesy waits patiently for your letters.

Shelley Ann Kealey is also confined. She is still being controlled, by lack of funds, from doing what she must do, regardless of what the consequences are to her own health. First, it was her union PSAC, with the former PM Brian Mulroney, through his agents Col. Bill McGill and Canadian Ambassador David

Dear Mike,

This is the follow-up fax to my telephone call of Jan. 5, 1998.

My call was made as a result of the receipt of a copy of the Formal Requirement to pay \$4,648.84 by Shelley Ann Clark that was sent in your name, c/o Anna Dentico, at National Life Insurance of Canada.

During our conversation you asked why the name S. Ann Clark meant something to you and I responded that I was not surprised it did, since it is well known by both our current Prime Minister, Jean Chretien and former Prime Minister, Brian Mulroney. Both participated separately and together in a plot involving high-treason against unsuspecting citizens of Canada.

This officially "protected" conspiracy, if ultimately successful, will directly affect the future of millions of still unborn Canadians. The actual vehicle used to perpetrate these crimes was the Canada-USA Free Trade Agreement (FTA), and later, the North American Free Trade Agreement (NAFTA).

Your current request is considered a much anticipated criminal extortion. It is being sponsored by the handlers and agents of the above mentioned traitors. It, obviously, is also intended to further isolate the whistle-blower in this case, Shelley Ann Clark.

The National Life Insurance Company and Government of Canada are currently operating as co-conspirators who have called upon their enforcer, Revenue Canada, to complete the task begun by them in 1988 — that is to isolate, financially destroy, ultimately, to carry out their original plan when they first attempted her murder in Europe.

I wish to advise you that it is my view as President and Chairman of the Canadian Institute for Political Integrity, the husband and agent of Shelley Ann Kealey who is currently on a long term disability leave due to post traumatic stress and being forced to take doping medication by the medical agents of her insurance company in order to follow their directives, that your "requirement to pay" order exceeds your jurisdiction, unless and until a judgment is rendered in the presence of the accused Canadian citizen concerned, within a court of competent jurisdiction.

Therefore, as of this moment your request is in fact null and void and any action undertaken by any party to enforce it will result in an information being deposited with a Justice of the Peace that will request a section 507 hearing to determine which are the appropriate Criminal charges that should be laid against them in the very same manner that charges were

once laid by us against the top three RCMP Commissioners in 1991. These charges by a Justice of the Peace ultimately led to their involuntary "early retirement".

Mr. Batten, I want you to understand that you, personally, along with your Government-corporate employers, will ultimately be held civilly and criminally responsible for your actions; actions that are without doubt designed to aggravate my wife's deteriorating medical condition. Nuremberg settled that precedent.

Once your actions are fully understood by Canadians — how you joined in the pattern of attack on Ann's health which began by those of the military attache, Col. Bill McGill, at Ambassador Peel's residence in Vienna and that continued through those of Ambassador Gerald Shannon in Geneva, they will react.

When unsuccessful in Europe the plot was continued when Ann returned to Canada.

Threats of death by bombing were received from fellow employees acting as messengers from management at Foreign Affairs Canada. Later, confirmation was given by the Department's internal security that the National Media could be controlled. Mr. Batten, your personal actions, along with those of your department, the government as a whole and of National Life Insurance cannot be viewed in isolation.

The National Life Insurance's recent escapade which saw Ann being sent to Richmond BC to visit their so-called "independent" doctor who turned out to be the President of the Canadian Medical Association (CMA) the insurance industry's prime lobbyist on the topic of the privatization of medicare in Canada just added to the intrigue.

The undeniable fact that the same Dr. Victor Dirnfeld was also in Vienna, during the attack on Ann at Ambassador Peel's residence, is also very

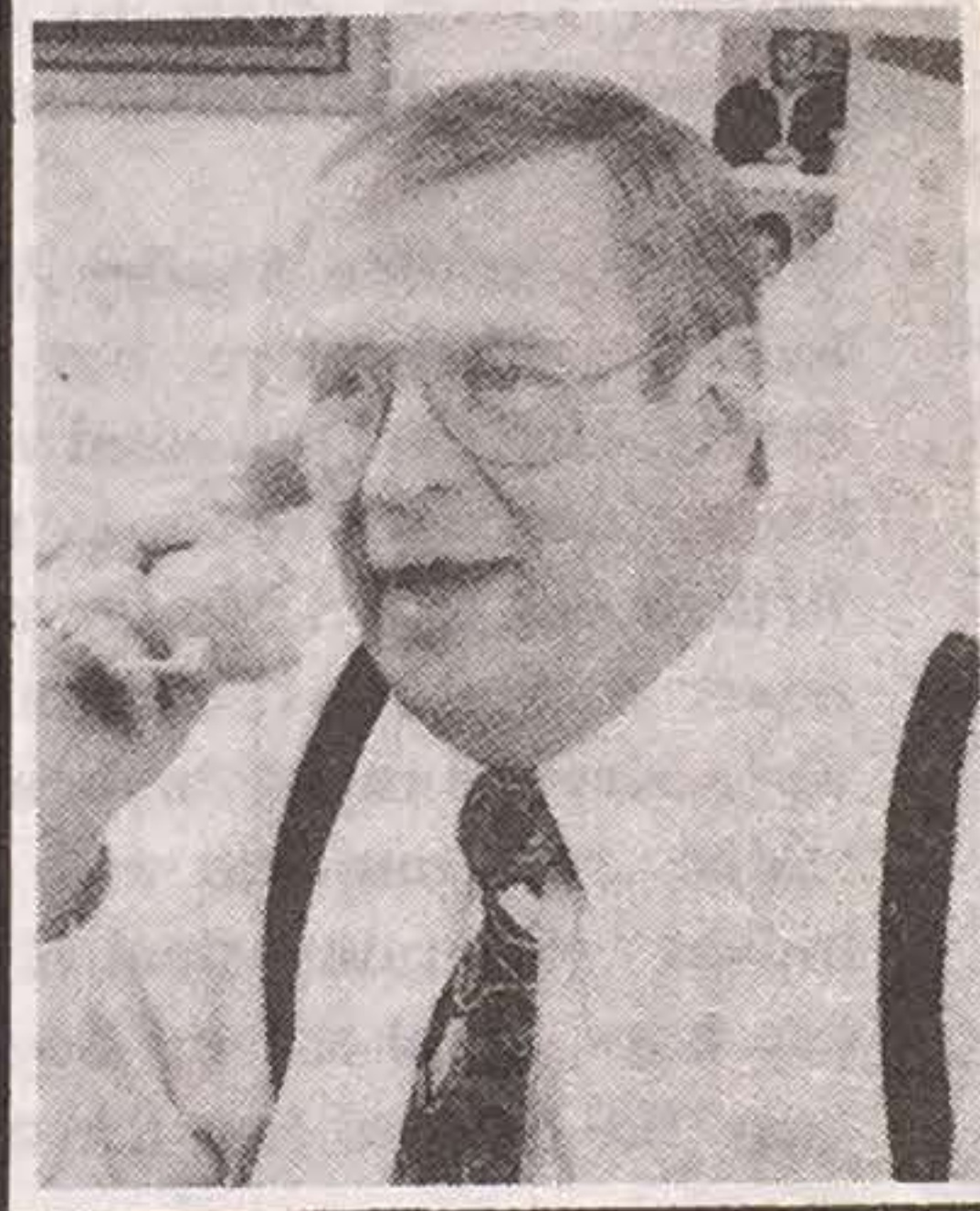

Kealey, through a Section 507 Hearing, succeeded in convincing a Justice of the Peace, with 34 years experience, to lay charges against 16 senior politicians and government officials, including Norman Inkster, Commissioner of the RCMP, Henry Jensen, Deputy Commissioner and J. Michael Shoemaker, Assistant Deputy Commissioner, with having conspired together in a criminal conspiracy intended to cease and limit police investigations.

Annhe Kealy, (formerly Shelley Ann Clark) is the civil servant, with 30 years experience, who worked for the Canada-U.S. Free Trade Negotiations Office in Ottawa and exposed an act of high treason committed by former Prime Minister Mulroney. She was ordered by the third highest ranking negotiator on Mulroney's team to come into the office between midnight and 4 a.m. in order to falsify and eventually shred briefing papers designed to mislead provincial premiers as to what was really being given away in the FTA (Free Trade Agreement). In March 1988, she was ordered by her boss to secretly remove key documents from the Free Trade Office and bring them to the trunk of his car. 5 and 6 point STARS are Mason symbols



The 6 point Star is used by Masons to depict the star of David. It is created by placing a triangle which faces downwards over another triangle that points upwards. In Masonry the triangle that points downwards symbolizes woman while the one facing upwards stands for man. Together, placed as they are, they symbolize the place where the final sacrifice will be made to give birth to a Masonic New World Order. It was designed by Nazi Masons (Sons of Legacy) to depict the area where many Jews are to be corralled and slaughtered, as a result of Armageddon, the third and final World War. Masons plan this war and according to them, Jews are not going to survive it. Millions will die in the middle East, while most others will die as a result of rising oceans — global warming causing a bi-polar melt down — due to this orchestrated nuclear war.

Kevin Kostner's recent film "Waterworld" depicts this outcome. Masons, themselves, are moving to ground that is higher than 1200 feet above sea level. Jews, on the other hand, were misled in their erroneous belief that Nazis were German, when in fact they were, and are, international free traders — Masons without borders. Jews all over the world are in imminent mortal danger. They don't even realize who their real enemy is.

The 5 point Star on the other hand is the symbol of Mason military power over money, politics, religion, media and entertainment. Everything that the military controls they

mark with a 5 point Star. We need only look at — 5 Star Generals in the military, the flags of the world, the "wise men bringing gold, pharmaceuticals and occult supplies" and the new cable movie channels with all their Stars. In Masonry terms their 5 point Star is made up of three parts.

The first is the circle at the centre which they describe as "the stone the builder rejected". The circle stands for their headquarters. It always remains hidden. Ten thousand years ago, when Masonry began, the circle was Mount Ararat located in today's south east Turkey. No visible sign of the Mason cartel's presence was ever constructed there. That would attract unwanted attention. They preferred to work through agents — puppet states, first Babylon and then Egypt. Today, since 1000 AD, headquarters are in Greenland. Its name means safe-land. During the last century France and England had fought over the right to be "puppets".

Now, since the end of WWII, that role belongs to the United States. It was chosen because the population is large enough to handle the military task at hand, while the current economy can be bled to provide the funds necessary to begin the exploration and militarization of space. As well, its central plains are an ideal place to locate a food cartel for the 21st century. It will be needed to feed the 2 billion who will survive Armageddon — that is, only until such time as these

humans can be replaced with "made-to-the-task clones".

The second part of a 5 point Star is more obvious. It's a pentagon. A 5 sided pentagon is used to identify the headquarters of their current military puppet.

The third and final part of the 5 point Star are the points themselves. Debate exists as to their real meaning. Some claim each point stands for one of the five sons of Amschel and Hanna Rothschild. They set out from Germany in the 18th century to establish international banking. Others say they are the 5 directions out of Babylon that were taken by the military as they set out to control the world — the middle-east — into Arabia, south — into Africa and India, the far east into Tibet, China and Mongolia, north-west — into Europe and finally, the Americas. Another version

believes the 5 points stand for military control over the then five known races — humans, animals, fish, vegetation and insects. To achieve this task one need only acquire control over money, land, water and the air. Whichever of these devilish possibilities one chooses to believe — the net result is the same.

Anyone who would undertake such a mission, let alone conceive it, is without a doubt, the "anti-creator".

interesting in developing the reasoning behind National Life Insurance's motives for sending Ann to see him instead of any other doctor. Also, their describing him as "independent" is a novel way of describing their own spies and agents.

As well, Ambassador Peel's recent promotion to the post of Inspector General of Canada's Intelligence and Security Service (CSIS), by the Liberal Government of Jean Chretien, Mitchell Sharp and Conrad Black, is but icing on the cake.

When added to National Life Insurance's latest actions, of depriving Ann of her income without notice — which prevented her from refilling the prescription for the medication prescribed by Doctor Gorman in Westbank, not to mention the obvious of food, rent, gas and hydro etc. — your additional request for a further piece of her reduced income is, we believe, the final straw that will awaken thinking Canadians to the sophisticated, organized criminal activity that presently masquerades as Government.

We at CIPI therefore insist, before you grab any of the little money Ann has, that you file a formal request before a court of law asking for a public hearing on the entire matter.

In Ann's defense she will demonstrate how she was deceived by her employer when it was stated that no deductions would be taken from her medical benefits and while recuperating she would

be able to count on 70% of her last gross income.

CIPI will also request "Intervenor status" in order to expose how the Department of National Revenue flexibly applies its own regulations in the case involving former PM Brian Mulroney's personal income taxes, as well as the case of the financial sponsors of your own former Deputy minister Pierre Gravel, in the TAXSAVE \$2 billion scam that was exposed to us by two of your auditors, Jim Weiten and Ted Reed of Winnipeg.

When considering all of the above, knowing how the criminals themselves have appointed the judges, we do not expect to get a fair shake within the Masonic Just-us system. However, the evidence which will be generated during the Hearing will allow CIPI to use its access to the internet, computers, fax machines and the networking of our 3,000 supporters to get the word out in Canada.

Consider yourself to be on notice and act accordingly. Canadians will know what happens.

One Canadian Woman's View

For the better part of my life I have worked two jobs to make a home for my two boys, being a single parent was a task I did with no problem. I paid taxes, gave money and time to local charities to help them raise money for people who did not have what I believed to be a chance to do it for themselves. Now, I am one of them. A physical disability took away my chance to create a life everyone needs.

Unable to work, I find myself working with the disadvantaged on a daily basis, as a volunteer on a crisis intervention telephone line. What I first thought was a small percentage of the population is fast becoming the norm in a category which I will call the working poor. To elaborate, these are people with young families, both parents are working, wages are minimum and the cost and quality of child care is a big worry for the parents as well as the cost of living being barely affordable. Job security is non-existent, and costs keep going up.

The myth that a good education and hard work will make one secure seems very tired.

How long are people going to believe that we have a huge debt that must be paid before we can have jobs, decent health care and hope for a future for the young people going to work every day and raising families?

There is something wrong when we are being lied to and are too tired and stressed out to hear the truth, let alone do something about it.

Greetings to you too!

I hope, Kathleen, that I have clearly and publicly answered your question and concerns.

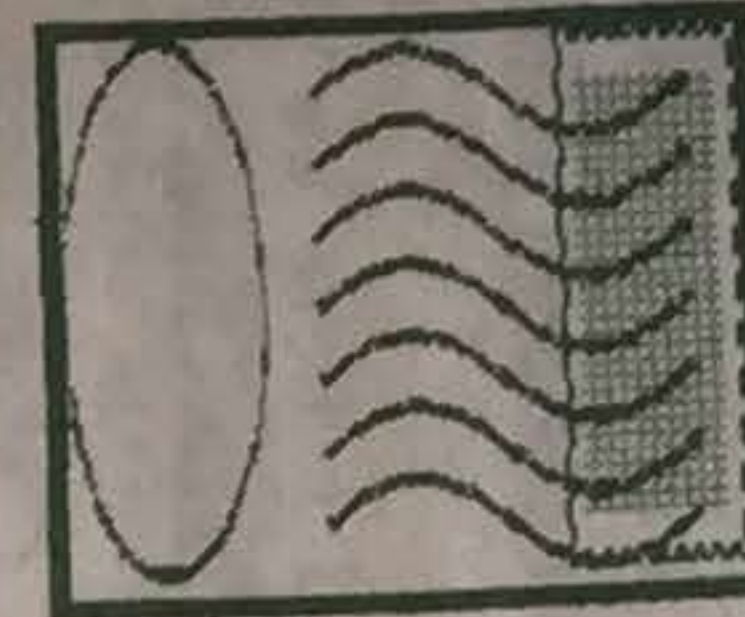
